It is brought to your kind notice that NHAI is engaged for construction of 4 laning of Phagwara-Rupnagar Section of NH-344A from km 0.000 to km 80.820 in the state of Punjab on Hybrid Annullity mode.

Forest proposal for diversion of 0.0256 Hac of forest land is being processed for approval to the Forest Department. The MoEF has envisaged the compliance of form-I (for linear projects) by the DC/Collector of the District Concerned. The land being diverted under above cited proposal, belongs to Ministry of Road, Transport and Highways, Govt. of India and the proposal does not involve recognized right of Primitive tribal Groups and Pre-Agricultural Communities.


