### THE BRIEF REPORT OF INSPECTION :-

The following are the merits of inspection conducted by the authorized signatory:-

- 1) The land proposed land bearing khasra no 521/2/2 measuring 00-03-57 being kabja swaym in the owner of govt. HP exists in hadbast no. 94 mohal BHARARA patwar circle kumarsain according to nakal jama bandi for the year 2009-10.
