1	In the geo referenced digital map of the area proposed for diversion, uploaded at C (iv) Part I online, geo coordinates are shown at very few points. May provide/upload scanned copy of GIS software generated geo referenced digital map to the exact scale of the proposed road showing geo coordinates at 200 to 300 m interval along the alignment including all turning points.	New fresh Geo referenced Digital map of the alignment showing coordinates 200 to 300m interval for the proposed road has been uploaded as per direction.
2	As per KML file of the alignment of the proposed road uploaded at C (ii) b Part I online, the last stretch of the road including a very long U turn appears to be extending too much inside the forest where are no villages located. The part of this long U turn can be shortened without leaving any habitation out thereby reducing the requirement of forest land and the no. of trees to be felled. May explore this possibility.	The last stretch of the road including a very long U turn appears is not for any habitation but it is for Jhiroli Magnesite Factory for which long U turn is appear.
3	As per information provided at A.3 Part I online, the application is filed by Rajesh Kumar Punetha, Ex En whereas the authority to file the application uploaded at A.3 (xvii) is in the name of Shri Mahendra Kumar. Authorization in favour of Shri Mahendra Kumar may be provided/uploaded.	Authorization letter of Sri Rajesh Kumar Punetha, Executive Engineer has been uploaded in A.3 Part-I.
4	As per Decision Support System (DSS) Analysis the area of CA shown in KML file of CA in Part I shows the extent of area as 0.04 ha instead of 9.3168 ha area proposed for CA. May upload KML file again showing the correct extent of area proposed for CA.	New fresh CA KML file has been prepared & uploaded in Part-I showing the extent of area of 9.3168 Hac. Instead of 0.04 ha area proposed.
5	Proceedings of the meeting of only Joshipalari Gram Sabha has been provided with FRA certificate whereas villages Dewaldhar & Naini also appeared to be involved.	Habitation Dewaldhar is connected with pauridhar-Dewaldhar-Palarichina-Jhiroli M/road & Habitation Nani is involved in Gram Panchayat Joshipalari, which is signed in FRA Praptra-23.1.
6	The digital map of area proposed for CA uploaded at L (v) Part I & 13 (ii) Part II online is different from each other. Further, this map is provided on google earth image which does not serve any useful purpose. Geo coordinates are provided for one point only and the map is also not in shape file. May provide/upload GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/closed area) file.	As per direction, New Digital map of area proposed for CA providing Geo Coordinates at all corner points in shape (polygon/closed area) file prepared & uploaded at L (v) Part I.

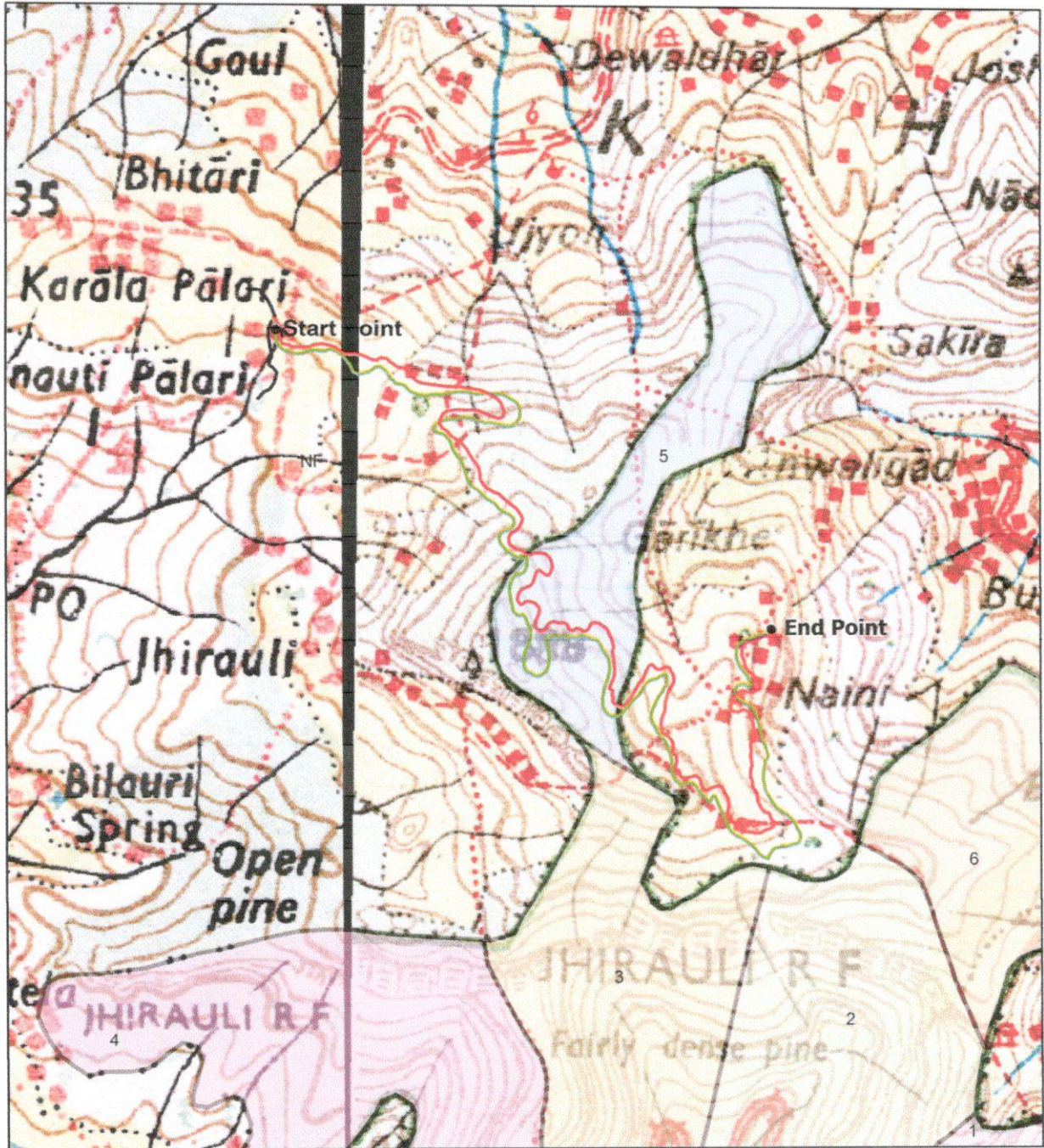
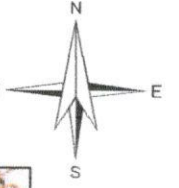

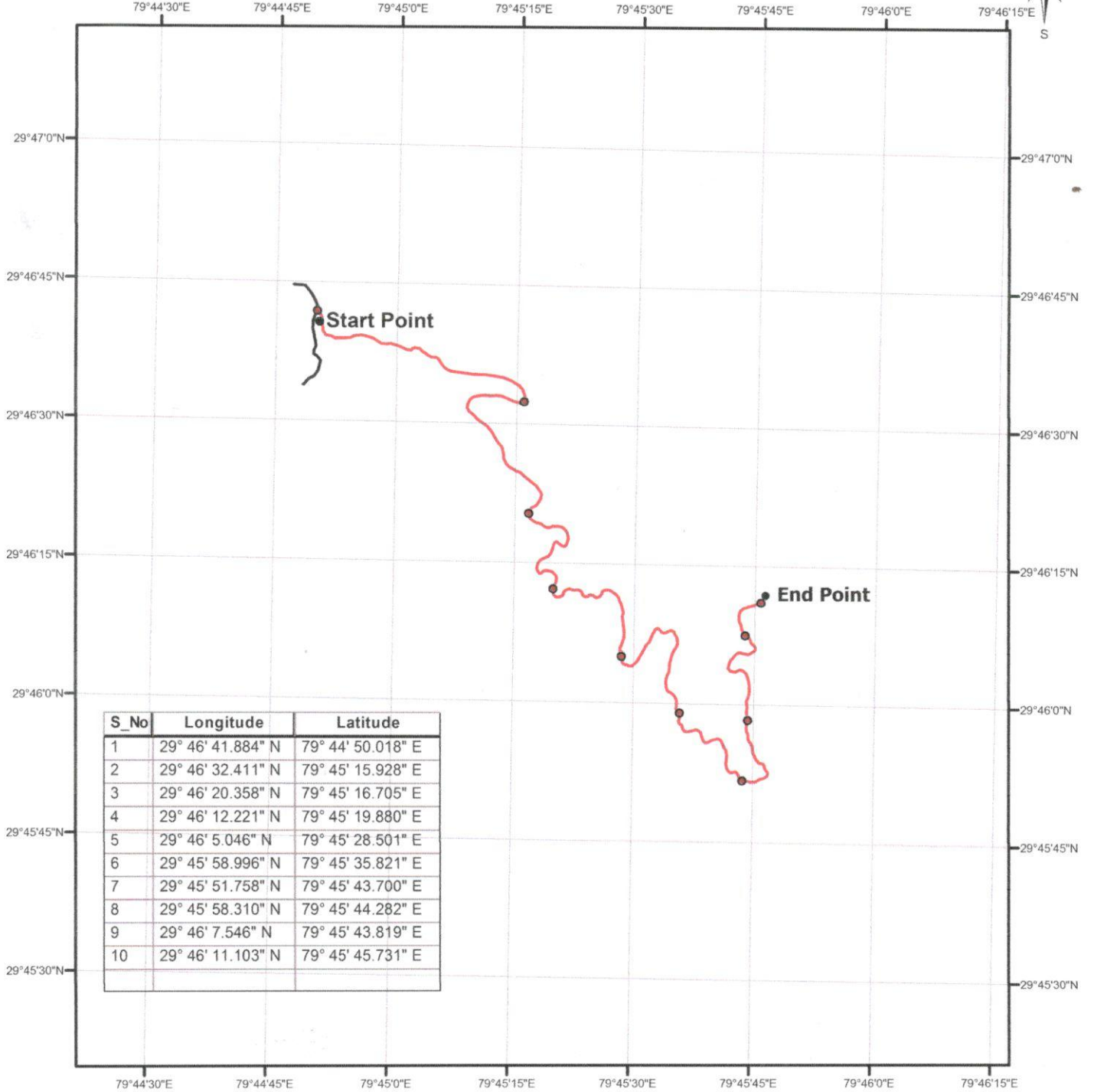
