Subject:- Permission to lay of 100 mtr HDD underground Optical Fiber Cable network from Alawalpur Chowk to FCI mall Godown in Palwal Distt.

You have deposited an amounting Rs. 26410/- through online vide Transaction ID 1668506819615 dt. 15.11.2022 & BG LOBGG01012206821 dt. 14.11.2022 & requested by you firm vide letter under reference, Permission to lay of 100 mtr HDD underground Optical Fiber Cable network from Alawalpur Chowk to FCI mall Godown in Palwal Distt. is hereby accorded subject to the following condition:-

- 1 As far as possible, the **Jio Digital Fiber Private Limited** shall carry out the work by using Micro trenching/Horizontal Direction Digging (HDD)/Horizontal boring methods so as to minimize damage the surface and cause least inconvenience to public.
- 2 The **Jio Digital Fiber Private Limited** shall have to provide barricading danger lights and caution boards at the work sites to ensure public safety.
- 3 The **Jio Digital Fiber Private Limited** is also expected to execute the work during off-peak times so as to cause minimum inconvenience to the public traffic;
- 4 Any traffic diversion from PWD Roads required during the execution of work shall be provided by the work executing contractor at the cost of the **Jio Digital Fiber Private Limited**.
- 5 The **Jio Digital Fiber Private Limited** shall lay the cable at the edge of the ROW within at minimum distance of 1.5 mtrs of PWD land.
- 6 The **Jio Digital Fiber Private Limited** shall ensure the safety of existing cables and shall be responsible for any damage to existing cables.
- 7 The **Jio Digital Fiber Private Limited** shall make its own arrangement for crossing crossed drainage structure/rivers, etc.
- 8 In case the **Jio Digital Fiber Private Limited** wants shifting/ repair or alteration of OFC, they will have to inform in writing to the concerned EE of PWD at least fifteen days in advance before starting the actual work.

9 In case of any damage to the essential services i.e. water supply , sewerage system and telecommunication lines, electricity supply etc, it will be the responsibility of the Jio Digital Fiber Private Limited to get the services restored to their original and satisfactory condition at its own cost;
Digging pits will be restored by your firm/department at its own cost.
