ANNEXURE-1
**Comprehensive Compliance Report pertaining to the Diversion of Forest land
in Varahi Lift Irrigation Project**

The Varahi Irrigation Project consists of Construction of Diversion weir, Varahi Right Bank Common Canal from ch:0.00km to 18.725km, Varahi Left Bank canal from ch:0.00km to 43.694km connecting Varahi Right Bank Common Canal through River Aqueduct constructed at ch:18.725km, Varahi Right Bank Canal from ch:18.419km to 23.67km.

The Varahi Lift Canal is a standalone Project off takes from ch: 6.10km of Varahi Left Bank Canal to irrigate the Command area in higher elevation which are deprived from gravity irrigation provided by Varahi Right Bank and Left Bank Canal. The proposed length of Varahi Lift Canal is 26.215km.

The Varahi Irrigation Project scope was contemplated during 1979 and was delayed till 1992 due to Policy level discussions at Government level. During this time, considering the delay in implementation, of the projects, it was decided to lift the water directly from the river through Lift head works and to feed Varahi Left Bank Canal from ch:0.00 to 21.00km to create the irrigation potential.

Accordingly Environment and Forest Department vide letter No. F (c)A/16.1/KAR/34/IP dtd:03/01/1996, has diverted 15.4ha of Reserve Forest for this Lift work. However, since the lift component was constructed near the river bank and water was let out into Varahi Left Bank Canal, the already diverted 15.4ha of Reserved forest was utilized under Varahi Left Bank Canal only. The Utilization of 15.4ha is as below:

Further, it is submitted that, as per Central Government Order dated:15/03/2004 and State Government order dtated:24/01/2005, 129.60ha of Reserve Forest was diverted for Varahi Irrigation Project. Out of 129.60ha, 89.11ha of Reserve forest was utilized under components like Varahi Diversion Weir, Varahi Submergence, Varahi Right Bank Canal and Left Bank Canal including Distributaries, Approach road to Diversion Weir, Dumping Yard in Weir site. Balance 40.49ha of Reserve Forest land was adjusted towards Deemed Forest as identified in Varahi Right Bank Canal and Varahi Left Bank Canal. Hence total 129.60ha of Reserve Forest land diverted to the Project is now fully Utilized. Utilization statement is as below:

At present, Varahi Diversion Weir, Varahi Right Bank Common Canal from ch: 0.00km to 18.419km and Varahi Left Bank Canal were completed. Now, Varahi Lift Canal which is a standalone project proposed to irrigate 2723ha of land in Udupi District is in progress. Since, this project is taken up for implementation nearly after 20years, No Reserved Forest land was utilized in this Stand alone new project out of originally diverted 129.60ha of Reserved Forest and 15.4ha of Reserved Forest.

Considering the facts as explained above, it is clear that, even though, the 15.4ha of Reserve Forest was diverted under component of Varahi Lift Canal in the year 1996, the utilization of forest was done under Varahi Left Bank Canal since, water lifted directly from river and let out in to the Left Bank Canal for irrigation. Hence No Reserved Forest land in this extent was utilized under the present stand alone new Varahi Lift Canal Project which is freshly taken up in the year 2018 after about 20 years of diversion of 15.4ha of Reserve Forest.

It is also submitted that, the lift Component constructed earlier in the year 2000, comes under private land and 15.4ha Reserve Forest is fully utilized under Varahi Left Bank Canal since water lifted from the river is fed to the Varahi Left Bank Canal for irrigation.

From 2015, the lifting of water from river and letting in to Left Bank Canal was stopped because, the Varahi Right Bank Common Canal was completed and got connected to Varahi Left Bank Canal through River Aqueduct and water let out in to the Canal from Diversion Weir.

The area proposed for Diversion of Forest under this project is 17.49ha; out of which 10.487ha of land comes under Reserved Forest and 7.003ha of land comes under Deemed Forest. Out of 7.003ha proposed Deemed Forest land, only 1.484ha area is now comes under Revised Deemed Forest List as per Govt order APG/185/FAF 2011 Bangalore dated 5/5/2022. It is requested now to divert 17.49ha of Forest land under this independent scheme which was not covered under any FC Proposal Cleared so far.

The user agency may therefore provide the digital map showing the location of the land proposed for diversion in the present project with reference to land already diverted for Varahi lift irrigation project (15.4 ha) and Varahi multipurpose irrigation project (129.6 ha) as per the approval given by the ministry vide its letter dated 03-01-1996 and 15-03-2004 respectively.
- The user agency may provide a comprehensive compliance report for the conditions stipulated in the approval issued by the Ministry for diversion of forest area for the earlier projects mentioned in Para no.1
