1. We would like to bring to your kind notice that our proposed approach road is not in the middle of the already diverted forest land to Ms Mahendra world city as mentioned in your above referred letter. The proposed approach road is at the end of the forest land allotted to Ms Mahendra world city. The starting point of our approach road is from the

Veerapuram village, Anjur village, Dharhas village road and not through the existing approach road allotted to Mahendra World City from GST road. In our online application we have clearly mentioned that we have proposed to develop housing units for the workers of Mahendra World City and hence all our movements is only from Mahendera World City, to Veerapuram Village. In the G.P.S drawing and KML file submitted , we have clearly shown our ingress and egress is from Veerapuram village, and the copy of the same is enclosed herewith. We have not intent to use the already diverted forest approach road to Mahendra World City, and hence the question of including area of the already existing diverted road to Ms Mhendra world city in our proposal Is not applicable

2. The above site has been inspected by several D.F.O's and C.C's many times during this period of our application and agreed that there is no alternative approach road is available to this S.F 86 of Veerapuram village, and recommended our proposal on the fringe of Thirutheri RF, and agreed it is the bare minimum forest land required. We have also produced the Collector certificate on this regard, Our site surrounded by forest on south and west side and other two sides are compounded by Multinational companies of Mahendra world city. So finding of alterative road or smaller area than our proposed road is completely ruled out and which can be easily seen in the GPS.and KML .

3.The Regional Director of forest,Government of India, has advised us to reduce the width of the road to 8 meters as against our earlier proposal of 12 meters width. We have submitted revised proposal as per the above advise.

As we have pointed out , now our company is trapped in between the forest and huge compounded Multinational companies Questioning of the DTCP authorities ,how they have permitted licence to the Multinational companies a decade ago with out giving road to our patta land is not possible for the small persons like us.

We have already stated that we have purchased this factory building and land from MS. SIPCOT, Tamilnadu Government Organisation on public auction. The above defunct factory was running from the year 1983, with the factory licence, panchayat licence. The copies of the above also submitted in our proposal.

Now we dont have any other approach road and the proposed road on the peripheral of the forest and end of the patta lands is the only hope we have.

It is very clear from the above, that our claim for approach road is genuine and deserving, hence we kindly request you to consider the above and forward your recommendations for the approval of this revised approach road.
