It has been requested vide reference cited to transfer twice the area of land namely 4.18.0 hectares of Government Poramboke land to the Forest Department as compensation for 2.09.0 hectares of land required for laying of 950 m, 110 KV lines in Kanuvai hill in Thadagam and Boluvampatty Block III reserve forest for establishment of 110/22-11 KV Somayampalayam Sub-station in Somayampalayam Village, Coimbatore (North) circle.

The Superintending Engineer/CEDC/North/Coimbatore /TANGEDCO has requested vide ref 2 cited to transfer the land required by the forest department free of cost considering the poor financial condition of TANGEDCO.

In this circumstances , it is hereby informed that action is being taken to transfer the 4.18.0 hectares of Government Poramboke land in SF.499, Thenkarai Village , Coimbatore(South) Circle requested by the forest department as compensation for 2.09.0 hectares of reserve forest land in Somayampalayam Village land required by TANGEDCO for establishment of 110/22-11 KV Somayampalayam Sub-station in Somayampalayam Village.
