Subject: - FCA cases (2183), Roads constructed in violation of FCA 1980-----  
Regarding initiating/starting process for seeking Ex-Post Facto approval  
under FCA 1980/FRA

It is well in your knowledge that 2183 roads have been constructed in Himachal Pradesh in violation of FCA 1980. From the information compiled by this office and sent to the Government, it has been found that the process for seeking approval under FCA 1980/FRA yet has not been initiated/ started by this department in respect of 495 cases having forest area less than 1 Hectare and in 685 cases having forest area more than 1 Hectare. It is also well in knowledge of all that the subject cited matter is being monitored by the Hon'ble High Court of Himachal Pradesh.

Hence all concerned are directed to initiate/start the process of seeking Ex-Post Facto approval from the competent authority in respect of 1180 cases at the earliest. The abstract of 2183 roads constructed in violation of FCA 1980 is also enclosed herewith for your information.

**Uploading of remaining road proposals on PARIVESH Portal for obtaining ex-post facto approval under the Van (Sanrakshan Evam Samvardhan) Adhiniyam.**

Sir,

It is to bring to your notice that the Government of India has raised observations in respect of certain road projects which are under process for obtaining approval, as these have been constructed in violation of the provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, and have been reported to the Hon'ble High Court of Himachal Pradesh due to non-uploading of the remaining road proposals on PARIVESH Portal for obtaining ex-post facto approval under the said Adhiniyam.

The Government of India has pointed out that although a period of six months has already elapsed, all the proposals have not yet been uploaded or processed for approval on the PARIVESH Portal. As per the information available, the user agencies have so far submitted only the abstract of **815 proposals**. However, the remaining proposals for regularization of encroachments under the provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 have not yet been uploaded on the PARIVESH Portal.

In view of the above, it is requested to upload the remaining proposals on the PARIVESH Portal at the earliest, so that the approval may be obtained from the Government of India in all remaining cases.
