13	Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.	:	<p>Alligudem is an illegal habitation and indulged in encroachment of Forest land. And there is every chance of further encroachment of Forest Land by the villagers upto Stafordpeta if there is road connectivity. Very less number of households existing in the Stafordpeta. Providing BT Road into interior area will open doors to the illegal encroachers( Gothi Koyas) from Alligudem to encroach upon. With limited number of staff it is very difficult to stop encroachments and illegal activities of Gothi Koyas. Hence, the proposal not recommended.</p>
