1	In the village wise breakup uploaded online at B 2.3 names of 2 villages are mentioned but village wise breakup of the area is not provided further , proceeding of meeting of only one Gram Sabha named Kalimati are provided with the FRA certificate but name of Kalimati village has not been mentioned in village wise breakup.	Corrected F.R.A uploaded in para K(a) of part -I
2	In reply to point no .5 of EDS dated 01.04.2016 of this office , the CA area has been corrected from 2.016 ha to 3.254 ha in the details provided at part I(L) but CA area still wrongly shown as 2.016 ha in the CA scheme uploaded in part II.	Corrected C.A. Maps are uploaded in para L(v) &(vi) of part I
3	The digital map of area proposed for CA provided in response to point no .7 of EDS dated 01.04.2016 of this office is on google earth map which does not serve any useful purpose may provide/upload GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/ closed area) file.	Corrected G.I.S.Maps uploaded in para L(v)
4	In response to point 10 of EDS dated 01.04.2016 of this office ,it is mentioned that the density 0.4 which comes in the Dense Forest category .However, in the calculation of NPV provided as additional document in part I, rate for very Dense Forest has been charged .	N.P.V is changed and uploaded in additional files as N.P.V. Evaluation
5	In reply to point 11 of EDS dated 01.04.2016 of this office ,it is mentioned that against 1031.955 ha land diverted ,CA has been carried out on 434.32 ha .However, in column 14 part II online the CA stipulated along with Panel CA against diversion of 1031.955 ha has also been shown as 434.32 ha. May show actual area of CA stipulated against forest land diverted so far.	Related with D.F.O
6	As per Decision Support System (DSS) analysis , against 3.254 ha area proposed for CA ,3 ha area is Moderately Dense Forest. State Govt may replace this 3 ha area with some other area suitable for CA and provide / upload revised digital map ,so I topohseet map and KML file of the complete 3.254 ha CA area again making the above change.	Fresh land for C.A.patch is provided. Revised Digital Maps uploaded in para L(v)&(vi) and KML uploaded in L(iv)-c
