Reply against the Essential Details Sought (EDS) for Forest Clearance (FC) application of Loc. MKD by Nodal Officer (FC Act) on 15.12.2017

Query:1: C-(ii)-(a)- After verification of the KML file posted by you through Email dated 05/12/2017, it reveals that the Plinth area & Approach Road area depicted in the KML files of does not tally with the proposed forest area mentioned in the column no.B-2.4 of Form A Part I.

As the proposed area for Plinth area & Approach Road area are 2.541 ha & 1.004 ha respectively whereas the Plinth area encompasses in the KML file is 2.51 ha and Approach Road is 1.034 ha. So please clarify or rectify the disparity.

- **The corrected KML file has been uploaded in the MoEF & CC portal.**

Query: 2: C-(iii) – The uploaded scan copy of 1:50,000 scale SOI toposheet map only depicted the Plinth area. The approach road connecting to the plinth area mentioned in the column no B-2.4, DGPS/total Station coordinates points, the co-ordinates readings of the proposed Plinth & approach road area has not been depicted. Hence a fresh map maintaining the full 1:50,000 scale toposheet reflecting all the aforementioned activities along with appropriate length and breadth of the proposed diversion area, legends and DGPS/total Station coordinates points and coordinates readings may be uploaded.

- **The corrected toposheet has been uploaded on the MoEF & CC portal.**

Query: 3: C-(iv) –The area mentioned (Plinth area 2.51 ha and Approach road 1.034 ha) in the uploaded scan copy of Geo-reference map does not match with the area fill in the column no. B-2.4 of the Form A Part 1. So please clarify or rectify the disparity and uploaded the same.

- **The modified Geo reference map has been uploaded in the MoEF & CC Portal.**

Query: 4: I-(i) - A copy of the application seeking Wildlife Clearance may be uploaded along with it reference no and date of issue.

- **The application seeking Wildlife clearance shall be submitted simultaneously along with the Forest Clearance application.**

Query: 5: M-2-(iv)-The uploaded document is a copy of 3-D subsidence analysis report and not the required approved mining Plan. So kindly upload the copy of approved mining Plan.

- **The approved mining plan has been uploaded in the MoEF & CC Portal.**

Query: 6: M-2-(vii) - No action has been taken for rectification / clarification of uploaded KML file of the outer boundary of mining lease area as E communicated vide our bservation dated 14/08/2017. So the KML files may be rectify / clarify and upload and also arrange to send a copy of the same to our Email address ad1pccf.nodal@gmail.com.

- **The Corrected KML file has been uploaded in the MoEF & CC Portal and sent to the above mail-id.**

Query: 7: Further, you are requested to kindly confirm whether the applicable full amount of 2% NPV paid against 9th PML includes the Mechaki PML or not.

- **OIL had already paid the full amount of 2% NPV against 9th PML includes the Mechaki PML.**
