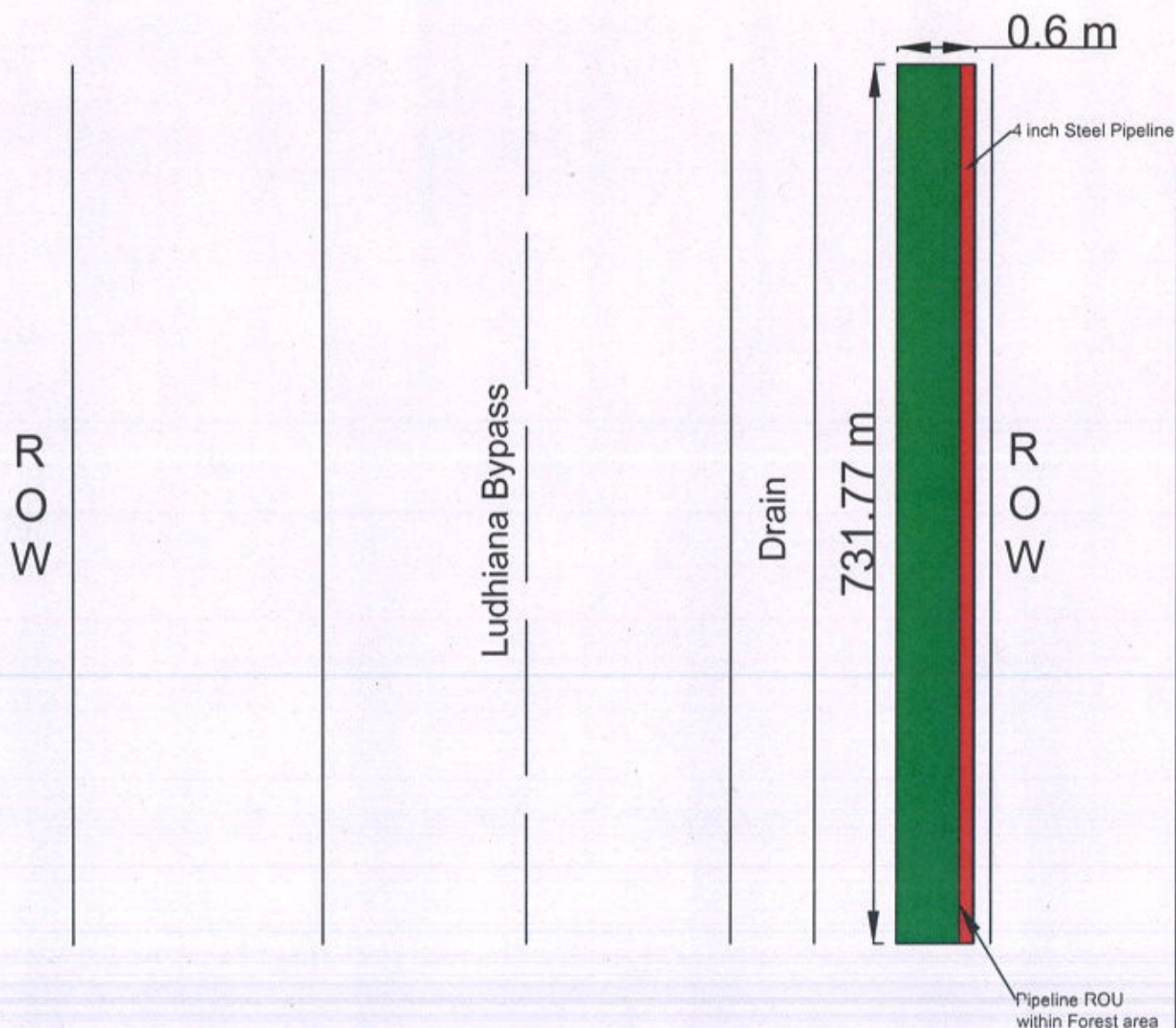

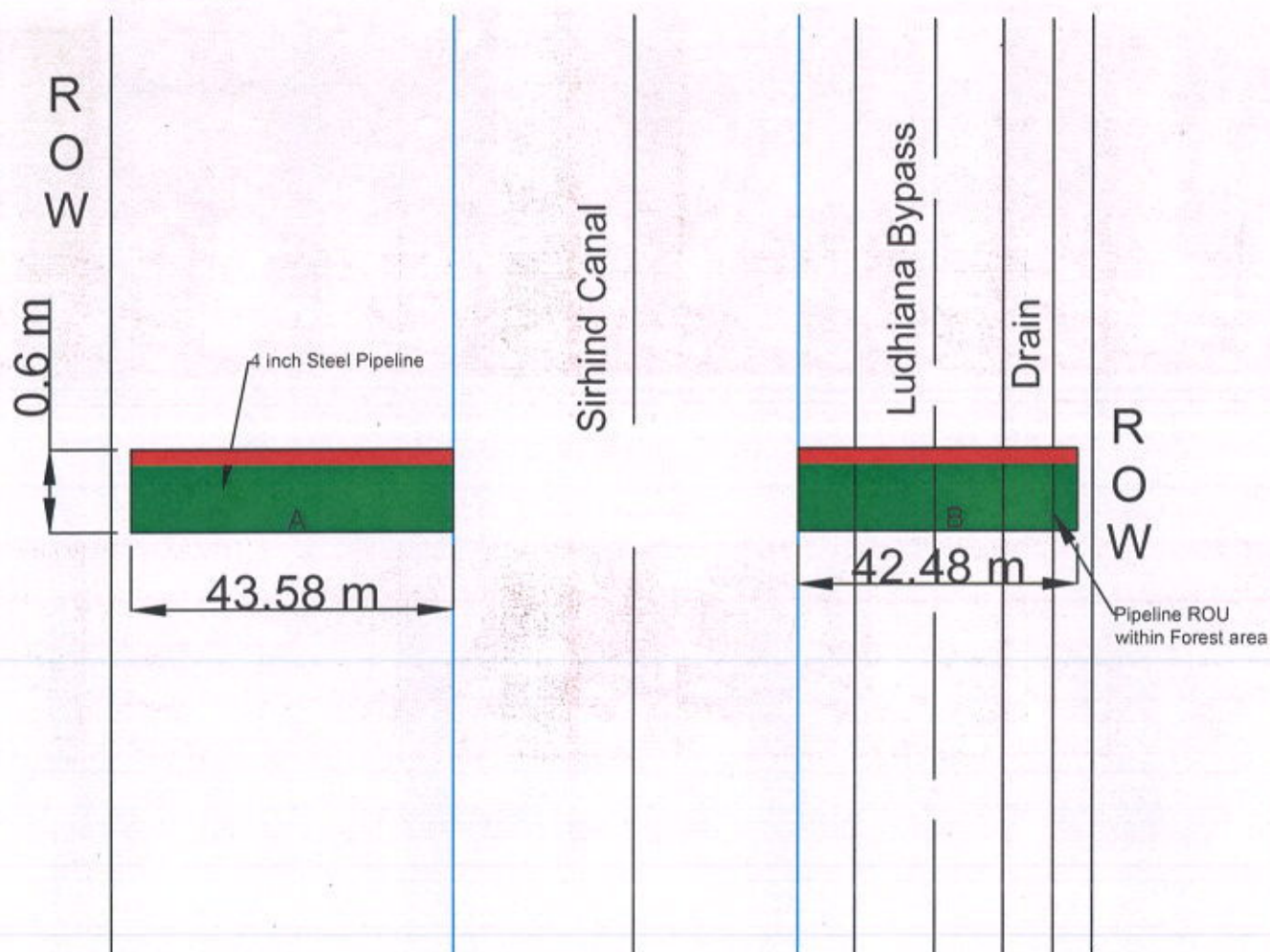


# Details of Protected Forest Area Sketch of Ludhiana Bypass & Sirhind Canal

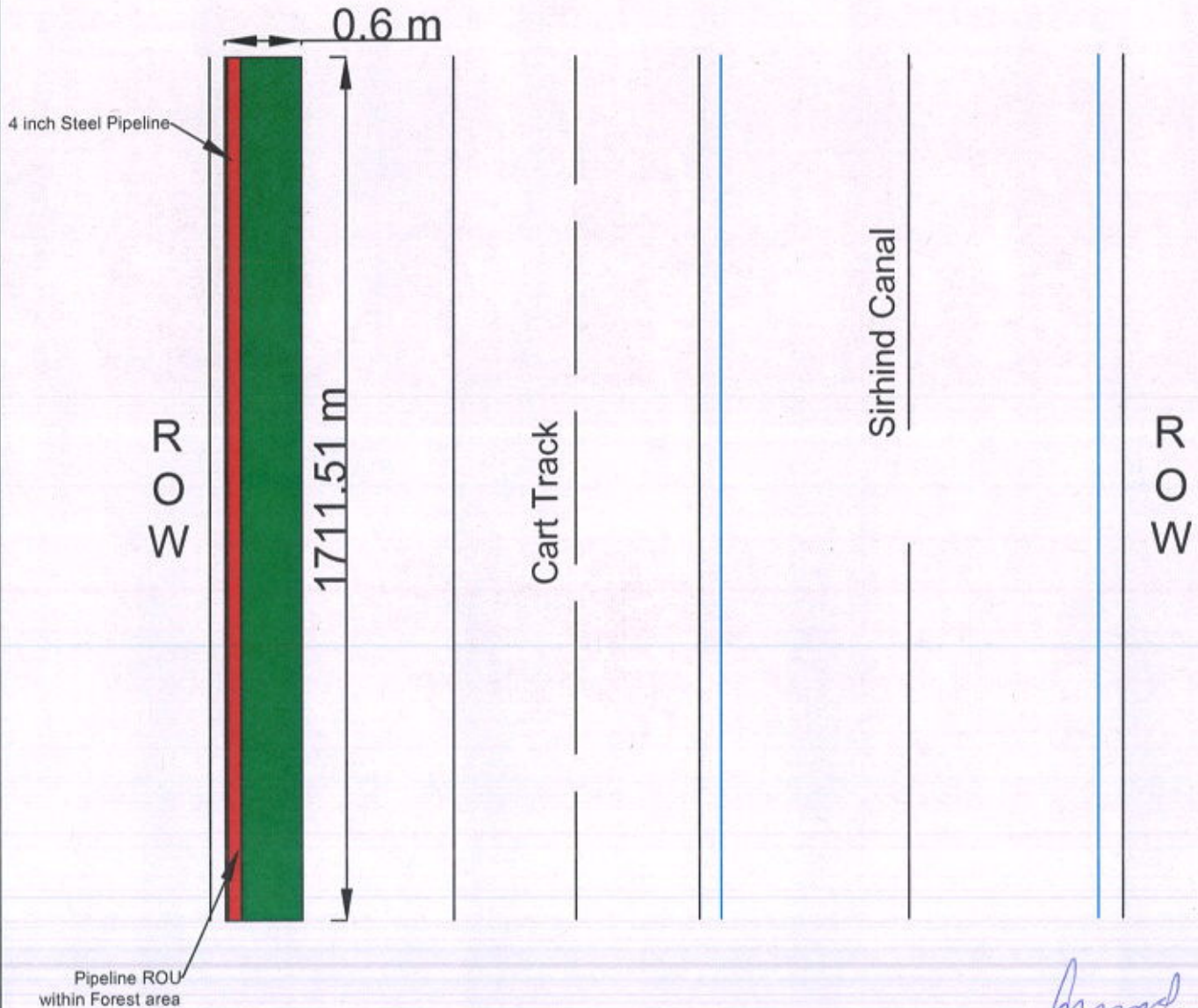

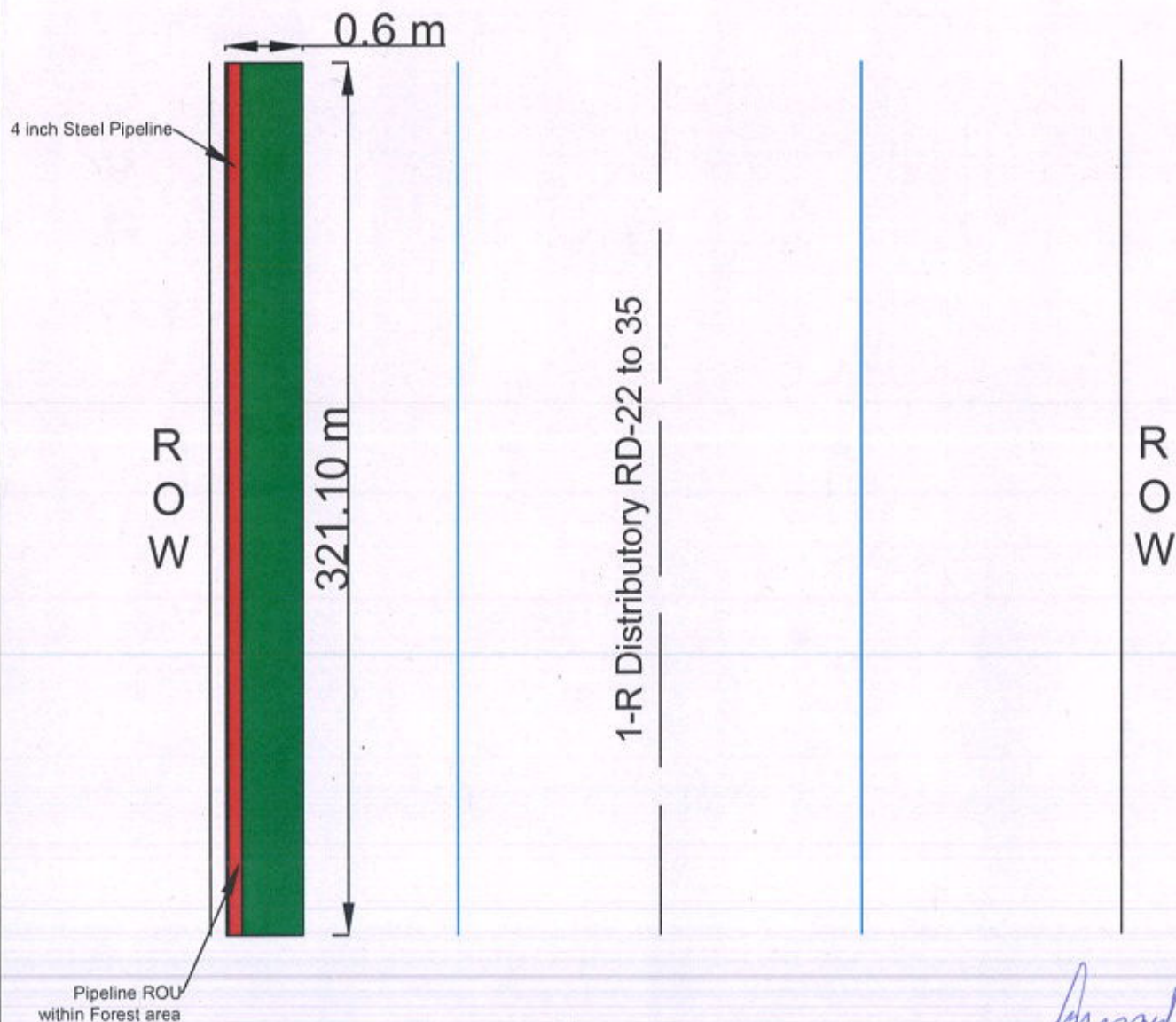

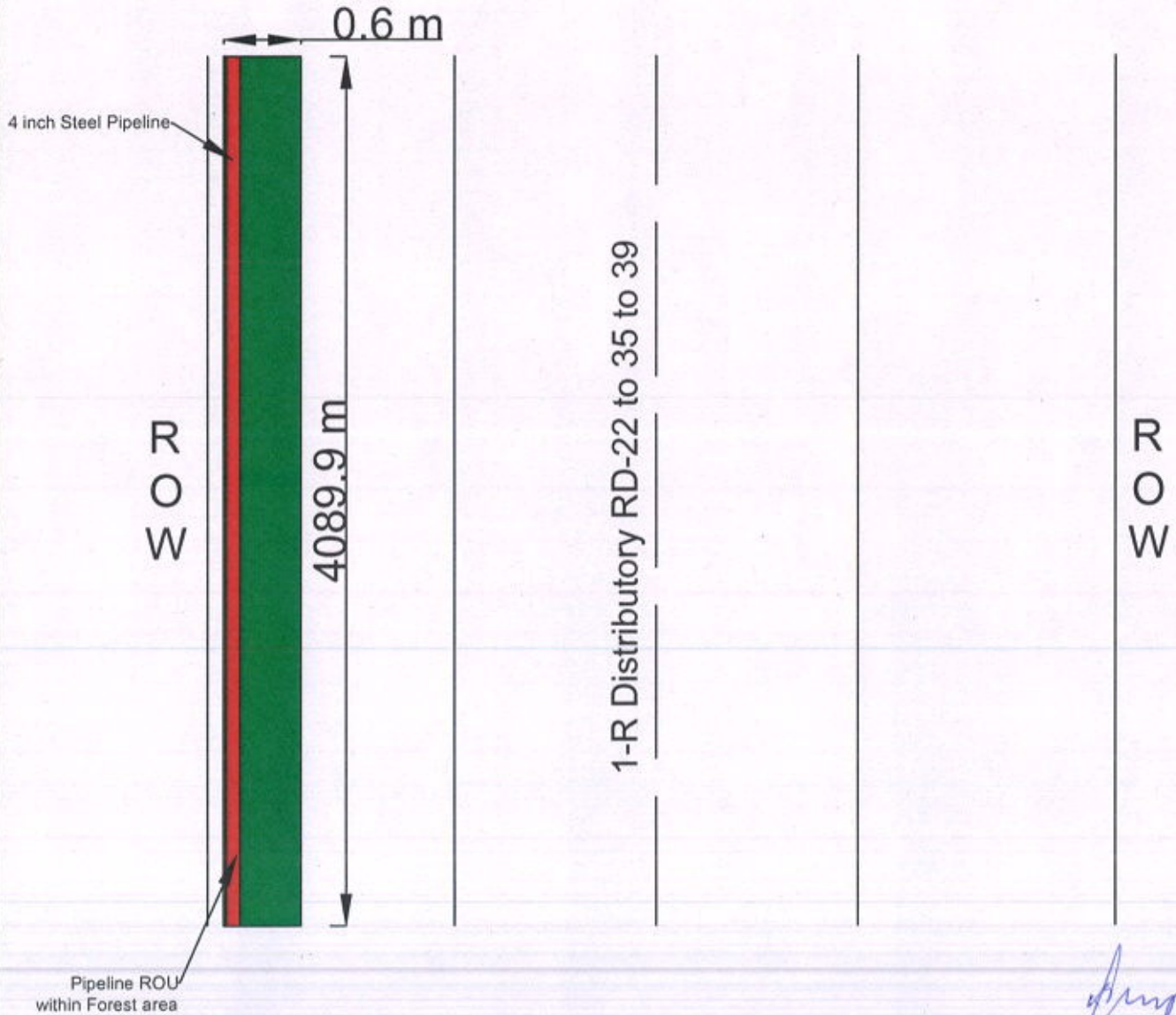
