Query:1: C.(ii)-(a) - KML file of the proposed diversion area has not been uploaded. Please upload the KML file.

- **KML file of the proposed diversion area has been uploaded on the MOEF & CC portal.**

Query:2: C-(iii) -Plinth area DGPS/total Station coordinate points have not been depicted in the legend of the uploaded scan copy of 1:50,000 scale SOI topo sheet map. Further, the uploaded SOI topo sheet (1:50,000 scale) map has not annexed the title of the map. Please rectify the same and upload accordingly.

- **The full 1:50,000 scale toposheet reflecting the Plinth area along with the DGPS/Total Station coordinates points and title of the map has been uploaded on the MOEF & CC portal.**

Query:3: C-(iv)-The uploaded geo-referenced map has not annexed the title of the map. Please rectify the same and upload accordingly. Further, it is to mention here that in the uploaded geo-referenced map, there are 4 nos of drilled wells have been depicted. Please clarify whether the 4 nos. of drilled wells obtained forest clearance? If yes, please provide the final approval letter of the aforesaid wells.

- **The revised geo-referenced map with the title of the map has been uploaded on the MOEF & CC portal. Further there will be only one drilling well to be drilled as depicted on geo-reference map.**

Query:4: K.(i)(a) - The uploaded undertaking in respect of FRA 2006 certificate has been submitted in plain paper. Please upload the required undertaking in non-judicial stamp paper.

- **The Undertaking for 2006 certificate has been submitted in non-judicial stamp paper and same has been uploaded on the MOEF & CC portal.**

Query:5: M-2-(iii) - The uploaded document is not a copy of the approval of Mining Plan. It is a copy of the regrant of Dumduma Petroleum Mining Lease measuring an area of 503.73 sq.km to Oil India. Please upload a copy of the approval of Mining Plan.

- **The Undertaking for the Mining Plan has been uploaded on the MOEF &CC portal.**

Query:6: M-2-(vi) - The uploaded document is a copy of the 3-D subsidence analysis report and not the required copy of the Approved Mining Plan. Please upload a copy of the Approved Mining Plan.

- **The Undertaking for the Mining Plan has been uploaded on the MOEF &CC portal.**

Query:7: M-5-(i) The total numbers of boreholes (13 nos.) mentioned in column no. M.5-(i) mismatched with the number of proposed boreholes depicted in the uploaded geo-referenced map. Please rectify the same and upload accordingly.


- **The numbers of boreholes has been corrected on the MOEF &CC portal.**

Query:8 : Further, it is to mention that no approach road has been depicted in the proposed project which is an important element for execution and future maintenance of the project. Please clarify whether the proposed project requires a forest area for the road? If yes, please incorporated the area of approach road in the proposed proposal.

- **The proposed project does not require a forest area for the road as there is already existing forest road which is passing adjacent to the proposed project site. Hence no new road is required for forest diversion.**
