Sub: Projects for electrification of 7172 Partially Electrified (PE) villages, 6385 Un-electrified Habitations (UEH) & 13066 Partially Electrified Habitations (PEH) and 407531 Rural households (including 158797 BPL households) in 8 Districts & 1 P.S. (of District: Nagaur) of Rajasthan State under "RGGVY" -Scheme for rural electricity infrastructure and rural households electrification under 12th plan.

Dear Sir,

Kindly refer the recommendation of State Level Standing Committee, forwarding the DPR's prepared by Jodhpur Vidyut Vitaran Nigam Ltd. in respect of Bikaner, Churu, Ganganagar, Jaisalmer, Jalore, Jodhpur, Pali, P.S. Ladnu (District: Nagaur) & Sirohi Districts for financial assistance of Rs. 67283.47 lakhs by REC for electrification of 7172 Partially Electrified (PE) villages, 6385 Un-electrified Habitations (UEH), 13066 Partially Electrified Habitations (PEH) and 407531 Rural Households (including 158797 BPL households) in the above districts.

- 2. We advise that the project has our approval for financial assistance under RGGVY 12th plan and REC is agreeable to sanction an aggregate amount of Rs. 67283.47 lakhs (Sixty Seven Thousand Two Hundred Eighty Three Lakhs forty Seven Thousand only) (details regarding loan and subsidy separately are as per Annexure-B2) to enable you to finance the cost of the above projects, subject to the terms and conditions provided in the Tripartite/Quadripartite Agreement to be executed amongst REC on behalf of Ministry of Power, the Government of Rajastham and Project Implementing Agency (Jodhpur Vidyut Vitaran Nigam Ltd. or JdVVNL) and mentioned in the following paragraphs and as set out in Annexure-A (Annexure-A pertains to detailed terms & conditions, which is being sent separately), B1, B2 & C (Project-wise) to this letter, which form part of letter.
- 3. The approved project shall be implemented by the State Government/JdVVNL, in accordance with the guidelines issued by Ministry of Power, GoI & any amendments thereto from time to time and the concerned Tripartite/Quadripartite Agreement to be executed amongst REC on behalf of Ministry of Power, the Government of Rajasthan and Project Implementing Agency (Jodhpur Vidyut Vitaran Nigam Ltd.)

- The project shall be executed on turnkey basis in accordance with REC's guidelines for "Procurement of Goods and Services for implementation of Rural Electrification Projects".
- 5. The present sanction is covered under the said agreement (to be executed) subject to the acceptance of the terms and conditions of this sanction as contained herein in this letter by the state government as per prescribed format enclosed (Attachment-I). The approval of financial sanction shall be operative from the date of signing of the acceptance letter by the State Government.
- 6. The process of declaration of electrification of Villages/Habitations sanctioned under the scheme shall be ensured in accordance with the new definition of electrification of villages notified by the Ministry of Power, Government of India vide their letter No.42/1/2001-D(RE) dated 5th February, 2004 read with their circular of even number dated 17th February, 2004, which amongst others clearly specified obtaining mandatory certificate from Gram Panchayat-regarding completion of Village/Habitation electrification & other requirements as specified in the RGGVY 12th plan guidelines.
- 7. State Government would ensure issue of appropriate public notification regarding sanction of this scheme specifically mentioning the following:
  - Number of un-electrified, partially electrified villages covered for electrification under the scheme (District and block-wise)
  - No. of Un-electrified & Partially Electrified Habitations (UEH & PEH) covered for electrification under the scheme (District and block-wise)
  - iii. Number of households to be covered for electrification under the scheme (District and block-wise).
  - iv. Time frame for completion.
  - v. Project is financed through REC under "RGGVY" Scheme for rural electricity infrastructure and rural household electrification.

On completion of the project, similar public notification shall be issued clearly indicating the requisites as above and the concerned MP, MLA, Chairman Zila Parishad, etc. shall also be intimated.

- 8. The following additional conditions are also part of this sanction;
  - a) The funds under the above projects, shall be released only after fulfillment of all requirements, by Govt of Rajasthan as per terms of sanction letter and in accordance with the Tripartite/Quadripartite agreement (to be executed).
  - b) 1st installment shall be released only after award of project duly accepted by successful bidder.
  - The projects shall be eligible for funding only after submission of the village-wise and habitations-wise surveyed details in RGGVY web portal by Project Implementing Agency (PIA)
  - d) The villages and habitations (of populations 100 and above) which have not been covered under the 10th & 11th plan are eligible to be covered under 12th plan.
  - e) The BPL Households which are yet to be electrified in the Villages/Habitations that have already been covered under 10th and 11th plan can be electrified under 12th plan



- e) with the existing infrastructure. The cost of BPL connections shall be considered as Rs. 3000/- per connection.
- f) Since the projects have been prepared based on detailed field survey, upward cost revision in the projects on account of quantity variations shall not be allowed by Government of India and any variation in the project cost for any reasons shall be borne by the State Government.
- g) No shortfall in the achievement of proposed infrastructure and outcomes i.e no. of villages, habitations & BPL HH's shall be allowed.
- h) The State Government/PIA shall implement the Three Tier Quality Control Mechanism as per RGGVY guidelines of 12th plan
- i) The projects shall be implemented as per RGGVY 12th plan guidelines.

The payments against the above project will be released only on receipt of grant from Govt. of India.

We shall be glad if you kindly advise us in the enclosed format (Attachment-I), of the acceptance by the State Government of the financial assistance, as set out in this letter, and as agreed to under the said Tripartite/Quadripartite agreement (to be executed), alongwith the standard terms and conditions indicated in Annexure –A (being sent separately), B1, B2 and C (Project wise) for availing financial assistance from REC.
