It is informed that ETS & DGPS/GNSS Survey data of the forest land proposed for diversion, for laying of Optical Fibre Cable in various districts/forest divisions furnished by the M/s Reliance Jio Infocomm Ltd, Hyderabad through references 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> cited have been verified, the extents of alignment passing through notified forests were estimated and communicated to the User Agency vide this office references 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> cited.

M/s Reliance Jio Infocomm Ltd, Hyderabad vide reference 7<sup>th</sup> cited has now informed that the authentication is approved considering **0.50 mts width**, for laying of underground Optical Fiber Cable trench for 4G cable.
