**KANNANKOTTAI THERVAIKANDIGAI RESERVOIR PROJECT HAS BEEN  
ANNOUNCED BY THE GOVERNMENT OF TAMIL NADU TO CATER TO THE  
NEED OF DRINKING WATER TO CHENNAI CITY.**

"Formation of new Reservoir near Kannankottai and Thervaikandigai villages in Gummidi poondi Taluk of Tiruvallur District" has been administratively approved vide G.O. in the Ref.1<sup>st</sup> cited.

In the project the OFF TAKE CANAL alignment was passing through the Reserve forest land in Senjiagaram, Thamarai kuppam and Palavakkam villages of Uthukottai taluk for an extent of 54.61 Acres.

In the same government order it is instructed to acquire the patta lands by land acquisition procedure and to transfer the Poramboke lands to the Public Works Department, which falls in the alignment of the off take canal.

Accordingly, the compensatory land for the forest land which are involved for formation of Off take canal to be transferred was identified by the Revenue Department. The land which can be given to Forest Department is as follows:-

Necessary action is being taken to Transfer the land to forest Department by the Revenue Department, for which necessary land Transfer Proposal is under process, it will be sent to Government shortly through the Commissioner of Land Administration.

After getting necessary Government orders the same will be handed over to the concerned Department.

Out of 115.00 Acres identified 109.22 Acre twice the extent of land may be transferred to the forest department as compensatory forest land of 54.61 Acre lands given to the Public Works Department for formation of off take canal.

I request that necessary concurrence for transferring the land in Uthukottai taluk for the Off take canal of "Formation of new Reservoir near Kannankottai and Thervaikandigai villages in Gummidi poondi Taluk of Thiruvallur District" may be issued early.
