Sub: - Issue of NOC for regarding Shanag Middle MHEP 100 KW (falling on Halindi Nallah left bank, Village & P.O. Shanag in Tehsil Manali District Kullu HP.

As per recommendation vide your office letter No.IE-JSDK-WA-NOC/2021-11707 dated 27.9.02021. The NOC in favour of **M/S Shanag Middle MHEP Prop Sh. Prakash Chand S/o Sh. Nokhu Village & Post Office Shanag, Tehsil Manali District Kullu** has been issued on the following terms and conditions: -

1. The firm shall enter into legal agreement with Jal Shakti Vibhag in this respect.
2. That the Chief Engineer (MZ), Jal Shakti Vibhag, Mandi shall be the sole adjudicator of any dispute arising during construction as well as subsequently and his decision shall be binding on all the parties.
3. In case, there is any scarcity of water due to drought or any other reason, the requirement of the Jal Shakti Vibhag shall have precedence over the requirement of this Project.
4. The firm shall ensure that the quantum of minimum flow of water to be released and maintained throughout the year immediately downstream of the diversion-site is a threshold value of not less than 15% of the minimum in flow observed in the lean-season to the main river water-body whose water is being harnessed by this project. The firm shall also ensure adequate minimum environment flow in the river below the diversion-site to take care of aquatic life and ecology of the area for which contract shall install real time monitoring system for out flow to maintain minimum flow prescribed above.
5. The firm shall rehabilitate/ repair/ compensate for the Jal Shakti Vibhag assets / water resource as well as Private Kuhls/ Irrigation Schemes / Water Supply Schemes in case these are damaged or adversely affected due to construction of the Project. During restoration period the arrangement for providing water to the beneficiaries shall be made through tankers and other alternative possible arrangement by the firm.
6. Additional water required of the department in future in addition to the project demand will get priority over the requirements of the firm.
7. In addition to Jal Shakti Vibhag requirement, the firm will also satisfy the requirement of private users, if any.
8. That the department will have liberty to draw water from **Halindi Nallah** (upstream and downstream) for construction of any irrigation and water supply schemes as and when required in future and if any schemes, sources of water at up and down stream of the HP get

affected, the executing agency will have to deposit the original cost of schemes including its remodeling and restoration, augmentation cost, as the case may be with the department in advance so as to make these facilities available to affected area for which the company will have no objection.

9. The present and future quantity of water for proposed WSS will be tapped by the department from **Halindi Nallah** upstream and downstream of the intake of the HEP and the department will have precedence over the requirement of the proposed project.
10. Company in rural area applying to the Vibhag will not be granted water from our existing schemes unless the scheme has sufficient water and the Gram Sabha of concerned Gram Panchyat pass resolutions approving the same.
11. Any damage direct and or indirect caused to the water source, water supply schemes or Irrigation Schemes shall be borne by **M/S Shanag Middle MHEP 100 KW Village & Post Office Shanag, Tehsil Manali District Kullu** with all financial and legal implication.
12. Any land required for restoration of the water source, water supply schemes or irrigation schemes shall be required by **M/S Shanag Middle MHEP 100 KW Village & Post Office Shanag, Tehsil Manali District Kullu** and transferred in the name of Jal Shakti Vibhag free of cost.
13. Any cost arising due to technical/ legal implication during construction of proposed scheme shall also borne by the **M/S Shanag Middle MHEP 100 KW Village & Post Office Shanag, Tehsil Manali District Kullu**.
14. The NAC (Non Availability Certificate) and permission to make alternative arrangements shall be granted by local Jal Shakti Vibhag Executive Engineer concerned.
15. The NOC is subject to the condition that land for relaying the pipe will be made available by the project executing agency i.e. **M/S Shanag Middle MHEP 100 KW Village & Post Office Shanag, Tehsil Manali District Kullu** and the cost of relaying will be also born by **M/S Shanag Middle MHEP 100 KW**

The above NOC is be issued and ensure that there is no scheme affected anywhere up steam/ downstream of the head weirs of said SHEP
