In the reference 1<sup>st</sup> cited, It is informed that to submit the additional information and documents for consideration of the proposal for formation of road from Thimmalanmedu to Kotturmalai on forest land in Kesarikuli RF and Thirumalvadi RL. The justification on the requirement of the 7.50 m width of road land width for the above hilly region road which is justified by the Executive Engineer, Rural Development Department, Dharmapuri is enclosed here with.

The area of the forest land proposed for diversion is identified as 2.91 ha and KML for the 2.91 ha and related formats are updated by this office. It is not able to edit following particulars in FORM-A of parivesh portal.

The land identified for Compensatory afforestation by this office in SF.No. 692/5 of No.18 Kammappatty Village. Nallampalli Taluk. But during the REC Committee inspection on 131.2.2022, it is informed that the identified land has already a good growth of vegetation and also the forest department suggested the Thoppur Reserved Forest for raising compensatory afforestation over 5.82 Ha. Hence, user agency will pay the entire cost of compensatory afforestation which to be done in Thoppur RF for the Forest land (Kesarikuli RF and Thirumalvadi RL) diverted for the above said road. All the additional details are updated in parivesh portal.

The total length of the road is 3.881 km and in that 2.136 km (1.602 Ha) length of the road falls (Kesariguli RF) within the Cauvery South Wild Sanctuary and it was excluded vide Go(MS) No 193 Environment Climate Change and Forests (FR5) department dated 07.11.2022 and the balance length of the road 1.745 km(1.308 Ha) falls in Thirumalvadi Reserve land which is within the default Eco sensitive zone of 10 Km radius. Hence to obtain the state board of wild life clearance is under progress and it will be submitted shortly.

Hence, it is requested to consider diversion of 2.91 ha of forest land in Kesarikuli RF and Thirumalvadi RL for formation of road from Thimmalanmedu to Kotturmalai.
