With reference to above mentioned letter the point wise reply is mentioned below: -

The different colours of the particulars in KML are as follows: i. The GM JJ land proposed for forestry clearance in the instant proposal measuring 2.12 Ha has been shown in "Yellow Colour". ii. The GM JJ land which has been already diverted under KBP OCP has been shown in "Green Colour". iii. The Tenancy Land required for Approach Road has been shown in "Black Colour". iv. Proposed Basantpur Tapin Coking Coal Washery has been shown in "Red Colour". v. The Project Boundary of KBP OCP has been shown in "Blue Colour".			
2.	As per new Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 & Van (Sanrakshan Evam Samvardhan) Rules, 2023. CA area needs to be proposed over equivalent non-forest land (NFL) instead of over degraded forest land (DFL) & accordingly revised CA	In this regard, it is to submit that it was very difficult to identify non forest land measuring 2.12 Ha adjoining forest land since as per rule applicable, CA Land less than 5 Ha must be adjoining Forest Land. Although, it has been managed to identify non- forest land measuring 2.12 Ha as CA Land adjoining forest land as required in the instant proposal for approach road to Basantpur Tapin Coking Coal Washery. Above identified land was acquired vide S.O. 981(E), dated: -22/12/1980 u/s 9(1) under CBA (A&D) Act -1957 and subsequently vested to CCL CCL vide S.O. No. 19/113/81-CL,			

documents like .kml file of CA land, suitability certificate, map, etc. need to be uploaded on PARIVESH portal. dated: -16/12/1981 lies in Basantpur Village, Mandu Circle of Ramgarh district.

The Proposal of identified non forest land for transfer as CA Land has been initiated on 30/04/2024 sent to CCL Hq, Ranchi after preparation of its KML and DGPS Plan. Land Schedule of above land had been authenticated on 24/05/2024 by the CO, Mandu (copy enclosed as Annexure-I).

The letter for mutation of abovementioned land was submitted to the CO, Mandu with kind information to the AC, Ramgarh vide letter no. PO/KBPOCP/24-25/77, dated: -03/07/2024 (copy enclosed as **Annexure-II**).

CCL Board has accorded its approval on dated: -22/07/2024 for the submission of the said proposal to MoC (Ministry of Coal) for its approval for the utilization of the said identified non forest land (tenancy land) measuring 2.12 Ha as CA Land against diversion of 2.12 Ha of forest land (GMJJ) for construction of approach road for Basantpur Tapin Washery (copy enclosed as **Annexure-III**).

Request letter vide no. 166, dated: -06/08/2024 has been sent to (Ministry of Coal) for approval for utilization/ handover of the aforesaid CBA acquired non-forest land (tenancy land) measuring 2.12 Ha to State Forest Department for CA purpose against diversion of 2.12 Ha of forest land (GMJJ) (copy enclosed as **Annexure-IV**).

Approval in this regard has been granted by Ministry of Coal vide letter no. 43022/5/2024-LA&IR, dated: -12/09/2024 with the condition that the proposed acquired non-forest land measuring 2.12 Ha may be given to State Forest Department for CA purpose against 2.12 Ha GMJJ (proposed to be diverted) without transferring its title (copy enclosed as **Annexure-V**).

Accordingly, mutation application has been registered through DA Login at CO Mandu office on dated: -23/09/2024. But, Mutation process could not be completed due to Jharnet Server problem. The DC, Ramgarh has been requested vide letter no. GM (H)/KBP/L&R/2024-25/423, dated: -09/12/2024 informing the difficulty in mutation process (copy enclosed as **Annexure-VI**).

Further it has been observed that online Register-2 is not updated in respect of Basantpur village of Mandu Block, as a result of which plot nos. with their respective area needs to be updated in online Register-2. Letter has been given to the CO, Mandu vide letter no.: -PO/KBP/L&R/24-25/427, dated: -10/12/2024 for updating the records of plots with plot area in online register -2 (copy enclosed as **Annexure-VII**).

The MoEF&CC has issued a letter on dated: -17/12/2024 (copy enclosed as **Annexure-VIII**) for streamlining of the approval process with regards to compensatory afforestation as envisaged in the Van (Sanrakshan Evam Samvardhan) Rules, 2023, point no(iv) quoted as under –

Quote

"As per the provision of the Van (Sanrakshan Evam samvardhan) Amendment Rules, 2024, projects of Central Government entities /CPSU and captive coal blocks of the state PSUs are eligible for raising CA over degraded forest land which will be double extent of the forest land being diverted. Accordingly, the State Government/UT shall not insist for providing non forest land as CA unless in cases where in the Central Government Agencies/CPSUs or State Government PSUs with captive coal blocks are forthcoming to provide non forest land available with them as CA or the State Government/UT Administration is willing to provides non forest land on such terms and conditions agreed by the Central Government Agencies/CPSUs or State Government PSUs in case of captive coal blocks."

Hence, It can been seen that after a lot of efforts and persuasion mutation of non-forest land identified as CA Land in favour of Central Coalfields Limited could not be done in last six months.

In view of the fact that this is a mining associated infra structure project which will be utilized for connecting the two Greenfield projects namely, Basantpur Tapin Coking Coal Washery Project and Kotre Basantpur Pachmo OCP.

So, it is a humble request that considering the above facts and the letter dated 17/12/2024 issued by MOEF & CC, double degraded forest land may be accepted. It may also be noted that Degraded Forest Land has been already in identified in Bongabar under Ramgarh Forest Division & Soft copy of KML file of CA land along with site suitability certificate and DGPS Plan has been uploaded.

In view of the above submission, it is humbly requested to kindly consider this forest diversion proposal considering double degraded forest land as CA Land and further for recommendation of Stage-I forestry Clearance.


Item No. 541.4(11): Proposal seeking administrative approval for utilization of non-forest land (tenancy land) measuring 2.12 Ha (5.25 Acres) at Basantpur village acquired under CBA (A&D) Act, 1957, to be used as CA (Compensatory Afforestation) Land against diversion of 2.12 ha of forest land (GM JJ) for construction of approach road for Basantpur -Tapin coking coal washery in District Ramgarh of Jharkhand.)

The Board was apprised regarding the subject proposal as below:

i. In order to comply the observation raised by ED in the letter dated 20/03/2024 against application for diversion of approach road to BasantpurTapin Washery, CA land of nonforestry (Tenancy) nature measuring 2.12 Ha (5.25 Acres) has been identified in village-Basantpur and District- Ramgarh.

ii. The identified tenancy land is a part of land, which has been acquired under Coal Bearing Areas (Acquisition and Development) Act, 1957 vide section 9(1) of the Act bearing S.O. No. 981(E), dated: -22.12.1980 and subsequently vested to CCL under section 11(1) of the Act vide S.O. No. 19/113/81-CL, dated: -16.12.1981. The proposed land (2.12 Ha.) is under possession of CCL. Land compensation and Employment has already been provided.

- iii. It has been stated by CMPDIL that "it is no longer suitable or economically viable for coal mining, RD RI-III has stated that no borehole has been drilled in the said patch and the borehole (CMB-06, 11) adjacent to the patch was drilled in Barren measure and closed without touching coal. However, top most Barakar seam i.e seam XIII is expected to be encountered at the depth of approx. 150m-180m from surface. therefore, the area of concerned is not amenable for mining."
- iv. As per Van (Sanrakshan Evam Samvardhan) Rules, 2023, the identified equivalent non forest land for CA shall be transferred and mutated in the name of forest department and notified as protected forest under section 29 of Indian Forest Act, 1927 or under any other law for the time being in force before the Final Approval is granted under the Adhiniyam.
- v. Since, the said land is acquired under CBA (A&D) Act, 1957, hence this land couldn't be transferred and mutated with any other department or agency, hence, it is decided that the said land will be handed over to State Forest department under the provision- clause 4 (5) (g) of Policy guidelines of MOC dated 22nd April, 2022.
- vi. Further as per Clause 8 (iv) of Guidelines on the Accredited Compensatory Afforestation in exceptional cases Government land may be transferred without transfer of ownership, which states that: The Forest Dept. shall give priority to such proposals and on receipt of "In Principle" approval said land parcel shall be transferred and mutated in favour of the State Forest Department and declared as protected forest under section 29 of

the Indian Forest Act,1927 or under any other law; However, in exceptional cases as decided by the Govt. of India on case to case basis, Government owned lands, where transfer of ownership of land to the forest dept. is not possible due to legal impediments, such lands, without changing their ownership, will be notified as Protected Forest under Section 29 of the of Indian Forest Act,1927 or any other local Act for the management by the Forest Department concerned as per the prescriptions of the working plan.

- vii. However, the Van Sanrakshasn Rules 2023 does not speak about mutation and registration of the land identified for CA purpose in the name of Forest Department, it says handing over the land to, the State Forest Department free from all encumbrances as per Clause 13(1) & 14(1) which are as follows:
- viii. Land acquired under CBA (A&D) Act may be considered on lease for its other use such as for Compensatory Afforestation (CA) for a lease period of 99 years as per Clause of 4.5(g) of Policy Guidelines of MOC dated 22/04/2022. For utilisation of such land by State Forest Department for CA purpose, no lease rent is required to be charged.

The Board after detailed deliberation, accorded its approval for the submission of the said proposal to MoC (Ministry of Coal) for its approval for the utilization of the said identified non-forest land (tenancy land) measuring 2.12 Ha (5.25 Acres) at Basantpur village acquired under CBA (A&D) Act, 1957, as CA Land against diversion of 2.12 ha of forest land (GM JJ) for construction of approach road for Basantpur-Tapin coking coal washery in District Ramgarh of Jharkhand, as brought out in the agenda note. The Board further observed that all other applicable necessary compliances in the said matter may further be assured.



Sub: Approval for hand-over of CBA acquired non-forest land (tenancy) measuring 2.12 Ha to State Forest Dept. for utilization as CA (Compensatory Afforestation) Land against diversion of 2.12 Ha of forest land (GM JJ) for construction of approach road for Basantpur-Tapin coking coal washery in District Ramgarh of Jharkhand.

Dear Sir,

The subject matter pertains to diversion of 2.12 Ha of forest land (GM JJ) for construction of approach road for Basantpur-Tapin coking coal washery in CCL. Key points with regard to subject matter are as follows:

- In response to CCL's application for diversion of 2.12 Ha of forest land for construction of said approach
 road, State Forest Department, vide its letter dated 20.3.2024 (Annex-I), has sought equivalent area of
 non-forest land for CA.
- To fulfil the aforesaid requirement for CA land, CCL has identified equivalent non-forestry (Tenancy) land measuring 2.12 Ha in village Basantpur of Ramgarh District. The identified land is part of land acquired under CBA Act vide S.O. No. 981(E), dated 22.12.1980 and subsequently vested to CCL vide S.O. No. 19/113/81-CL, dated 16.12.1981 (Annex-II). The proposed land is under possession of CCL for which compensation and employment has already been provided.
- CMPDIL has examined mining potentiality in the said CBA acquired land and observed that the identified parcel of land is not suitable/amenable or economically viable for coal mining.
- 4. Various rules/guidelines governing utilization of non-forest land for CA (issued by MoEFCC) and use of CBA land for other purposes (issued by MoC), which are relevant to the subject case are deliberated hereunder:
 - a. Clause 13(1) & 14(1) of Van Sanrakshasn Rules 2023 (Annex-III) deals with CA and provides for handing over the equivalent non forest land by the User agency for CA purpose to State Forest Department free from all encumbrances.
 - b. Clause 8 (iv) of MoEFCC's Guidelines on ACA (Annex-IV) provides that in case of utilization of Government owned lands for ACA, where transfer of ownership to the forest dept. is not possible due to legal impediments, such lands, without changing their ownership, will be notified as Protected Forest under Indian Forest Act.
 - c. Clause of 4.5(g) of MoC's Policy Guidelines dated 22/04/2022 (Annex-V) provides that Land acquired under CBA Act may be considered on lease for other use such as CA for a lease period of 99 years



- 5. In light of the above rules/guidelines, the subject proposal for handover of CBA acquired non-forest land to State Forest Dept. for CA purpose was deliberated and approved by CCL Board on 22.07.2024 (Annex-VI) with a direction to obtain MoC's approval for the proposed handover.
- 6. On a similar request, MoC, vide its letter dated 8 July 2024 (Annex-VII), had advised ECL to register its non-forest land with State Forest Dept. for ACA purpose without transferring the title.

In view of the above, Ministry is requested for the following approval/assistance to facilitate CCL obtain early Forest clearance for timely construction of approach road for Basantpur-Tapin coking coal washery:

- Approval for utilization/hand-over of the aforesaid CBA acquired non-forest land (tenancy land)
 measuring 2.12 Ha (5.25 Acres) to State Forest Dept. for CA purpose against diversion of 2.12 ha of
 forest land (GM JJ).
- MoEFCC may please be requested for issuance of a direction to State Forest Dept. for accepting nonforest land for CA purpose without transfer of land ownership on lines similar to Clause 8 (iv) of MoEFCC's Guidelines for ACA purpose.

- This issues with the approval of competent authority.



Sub: Streamlining of the approval process with regards to compensatory afforestation as envisaged in the Van (Sanrakshan Evam Samvardhan) Rules, 2023 as amended on 20.09.2024 – reg.

Madam/Sir,

I am directed to refer to the above subject and to inform that based on the references received from the Ministry of Mines, and Ministry of Coal, the provisions related to raising of compensatory afforestation, as envisaged in the Van (Sanrakshan Evam Samvardhan) Rules, 2023 as amended on 20.09.2024, have been reviewed by the Ministry and after due deliberations, the Central Government, in accordance with the provisions of section 3C of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 hereby issues the following clarifications:

- i. Provisions of Rule 14(1) of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, provides that the non-forest land identified for raising Compensatory Afforestation (CA) is to be notified as Protected Forests before final approval (Stage-II) approval is granted by the Central Government. However, in cases where non-forest land identified for CA has been transferred and mutated in favour of the State Forest Department (SFD), the Central Government may accord final approval keeping in view the fact that provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 become applicable on such lands being entered as forest in government record/record of rights.
- ii. In such cases, referred in para (i) above, the non-forest land forest land proposed for CA, shall be notified as Protected Forest under section 29 of the Indian Forest Act, 1927 of local forest Act before handing over of forest land to the User Agency by the State Government. The Nodal Officer, after notification of such non-forest lands, shall upload a copy of said notification on the PARIVESH portal.
- iii. For the purpose of rule 13(4)(a) of the States or Union territory Administrations, having forest area more than 33% of their total geographical area, concerned State Government/UT Administrationmay authorise a suitable officer to issue certificate of non-availability of the suitable non-forest land for raising CA.
- iv. As per the provisions of the Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024, projects of Central Government entities/CPSU and captive coal blocks of the State PSUs are eligible for raising CA over degraded forest land which will be double in extent of the forest land being diverted. Accordingly, the State Government/UT shall not insist for providing non-forest land as CA unless in cases wherein the Central Government

Agencies/CPSUs or State Government PSUs with captive coal blocks are forthcoming to provide non-forest land available with them as CA or the State Government/UT Administration is willing to provides non-forest land on such terms and condition which is agreed by the Central Government Agencies/CPSUs or State Government PSUs in case of captive coal blocks.

v. With regards to the applicability of the provisions of the Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024 in respect of proposals of the Central Agencies/PSUs and captive coal blocks of the State PSUs which were granted 'in-principle' approval stipulating CA over non-forest land, the

following clarification is given in this regard:

a. Proposals, which were submitted by the States/UTs before notification of Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024, along with the proposal of raising CA over degraded forest land (DFL) and were granted 'in-principle' approval stipulating CA over non-forest land (NFL), shall be allowed to submit compliance of 'in-principle' approval along with CA proposal over DFL in lieu of NFL. The Central Government will consider and grant final approval in such cases stipulating CA over DFL.

b. Proposals, which were submitted by the States/UTs along with CA proposal over non-forest land and were granted 'in-principle' approval stipulating CA over non-forest land (NFL), can also be allowed to submit compliance of 'in-principle' approval along with CA proposal over DFL provided the non-forest land proposed for CA is not transferred and mutated in favour of the State Forest Department. In such cases, the Central Government or its Regional Office, based on the request of the State/UT Government or user agency, shall amend the condition of in-principle approval to raise CA over DFL on a case to case basis and subsequently the User Agency shall submit the compliance of in-principle for the obtaining the 'final' approval.

In view of the above, the State Government and Union territory Administrations are requested to take into consideration the guidelines mentioned hereinabove while considering the proposals submitted under section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.
