Respected Sir,

With reference to your letter dated 26-12-2024 regarding the diversion of 0.4928 hectares of forest land in Survey No. 215/A/1A of Arav village, Gopshitta Range, Karwar Division, I would like to bring to your kind attention the following points:

1. The recommendation letters from the Director of Mines and Geology Department and the Office of the Tahsildar, Uttar Kannada District, were duly submitted along with our proposal. Additionally, the Geologist from the Mines and Geology Department has surveyed the proposed area and provided consent for quarrying activities. For your convenience, copies of these documents are enclosed once again with this letter.
2. The earlier quarrying activities were undertaken only after obtaining the required surveys and approvals from the Office of the Deputy Conservator of Forests, Karwar, and after payment of the requisite royalties, as specified in the permits. These approvals were granted based on the needs of the local public at that time and the extracted boulders were utilized for development of local infrastructure. The surveyed map and permit issued by your Office were included in the proposal, and copies of these documents are once again attached here for your reference.

We have attached all the relevant documents to this letter for your future reference and have updated on the FC web portal as stated in your letter. We request your office to expedite the processing of the proposal, as all necessary documents requested have already been furnished beforehand.



This permit shall be valid upto **45-** days only from the date of issue work orders by the Range Forest Officer.

The depth of the pit below the surface shall not exceed six metres.  
This permit is non-transferable.

No other mineral except than for which the permit is granted shall be excavated or removed without proper sanction being obtained from the competent authority.

5. If any other minor or major minerals found during quarrying operation, it shall be reported to the competent officer within a week's time after such discovery.
6. The permit holder shall maintain complete and correct account of the mineral excavated quantity removed from the permit area the sale vouchers register of labour employed nad wages paid etc., and royalty and other charges leviable for this purpose.
7. The permit holder shall immediately report all accidents to the competent officer and the District Magistrate and the District Superintendent of Police of the District in which the area is situated.
8. The permit holder shall have no right over the quarry material and other property lying in the permit area after the expiry of the permit.
9. The permit holder shall not cut or damage any trees without proper sanction and without payment of compensation thereon as may be fixed by the Deputy Conservator of Forests or such Officer authorised by him in this behalf.
10. The permit holder should obtain necessary transit pass for each load from the concerned official of this Department, failing to which the licence shall be cancelled at once and no further application will be entertained from such defaulters.

11. The permit holder shall not carry quarrying operation with a distance of 50 Mtrs., from any public roads, public buildings or temples, reseroirs, burinal ground and Railway track, etc., and cause any damage to any public or private properties.
12. The permit holder shall allow any officer authorised by the Districtor of Mines & Geology and the local revenue, Forest authority in whose jurisdiction the land is situated to enter into and inspect at any time the quarrying operation and check up the documents and verify the details of despatch sales, etc., from the account books maintained by the permit holder as per conditions(7) above or near the area under permit.
13. If any excess quantity over that permitted is found to be removed the material shall be confiscated and the permit holder shall be liable for punishment under the provisions of the Karnataka Minor Mineral Rules, 1969.
14. If any breach of the these conditions or the Karnataka Minor Mineral Rules 1969 is detected, this permit shall be cancelled and the material laying on the site will be confiscated.
15. As soon as the removal of the material granted under the permit is over, the permit holder surrenders the permit to the competent Officer and furnish to him a complete statement showing the quantities removed, detailed of transport and parties to whom this material has been sold, and prices obtained therefore, and shall produce and details, book, etc., for the scrutiny of the competent office as may be called for by him.
16. The original permit is to be returned to this office after expiry of the period or handed over the the Range Forest Officer concerned for file.




