1.	State Govt. has submitted a scheme for planting of 4200 no. of seedlings (420x10) and the cost has been workout to Rs. 62, 28,031.62 which is very much exorbitant against diversion of 0.91 ha of Van Panchayat Land. State Govt. may propose CA plantation over 2.00 ha instead of planting of seedlings 10 times the no. of trees proposed to be felled. The CA scheme, Site suitability certificate, Geo-referenced digital map and the map in Survey of India Toposheet may also be submitted against the CA to be proposed over 2.00 ha.
