Sub:- Grant of Prospecting Licence in the district of Koraput/Kalahandi.

Read:- Application presented on 7.11.90 by M/s. Larsen & Toubro Ltd. for grant of Prospecting Licence over an area of 13.5 Sq.Km. for Bauxite in village Sijimal in the Districts of Koraput/Kalahandi.

ORDER:

Whereas M/s. Larsen & Toubro Ltd. have applied to the State Government for grant of a Prospecting Licence by their application read above ;

Whereas the mineral in the land in respect of which the Prospecting Licence has been applied for belongs to Government and the land is at their disposal ;

Whereas the applicant being an public limited, 18 out of the 21 Directors are citizens of India ;

Whereas the Government of India have conveyed their approval to the grant of P.L. under Section 5(1)(a) of the M&M (R&D) Act, 1957 and they have also in exercise of the powers conferred by Section 6(1)(a) of the said Act, directed the State Government to take into consideration of this P.L. application and pass orders vide their letter No.2(80)/91.MIV Dt.22.5.92 ;

Whereas the party was asked in this Department letter No.6094/SM. dt.27.5.92 to accept the terms & conditions under which the Prospecting Licence was proposed to be considered for grant and the party in their letter No.S&M:ALMN:DKP dt.6.6.92 accepted those conditions ;

Therefore, the State Govt. are hereby pleased to order that a Prospecting Licence for Bauxite in respect of the land over 13.5 Sq.KM. in villages Sijimali etc. in the district of Koraput & Kalahandi be granted to M/s. Larsen & Toubro Ltd. for a period of two years subject to the conditions laid down in the State Govt. letter No.6094/SM. dt.27.5.92. The party should comply with all the terms and conditions including furnishing of a surveyed map and description within 45 days from the date of this order to the Collector, Koraput.
