With reference to the above subject it is to inform that Steel & Mines, Govt. of Odisha vide letter No. 7731/IV(B)SM-100/2017/SM, Bhubaneswar on 21.09.2021 issued us a "Letter of Intent" for grant of Mining Lease over an area of 131.889 Ha (DGPS authenticated area over 131.800 ha) for Laserda-Pacheri Manganese and Iron Ore Block in villages Dhanurjoypur, Kanarda & Laserda under Champua Sub-division, Barbil Tahasil of Keonjhar district in favour of M/s. Thriveni Earthmovers Pvt. Ltd.

Out of the total lease area, 94.351 Ha is coming under forest land which includes 40.884 ha of non-forest land recorded as forest as on 25.10.1980. As per the LoI, obtaining Forest Clearance is an integral part of the terms & conditions. Therefore, now we are in the process of applying the "Diversion Proposal" over the aforesaid forest area to the MoEF & CC, GoI under section 2 of FC Act, 1980.



In compliance to the MoEF & CC letter No. 11-9/98-FC (pt.) dated 30.07.2009, 03.08.2009, the Certificate under Schedule Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 for the forest land over 94.351 Ha (Entire forest land involved within the granted LoI and subsequent DGPS authenticated area) is required in favor of Laserda-Pacheri Manganese and Iron Ore Block of M/s Thriveni Earthmovers Pvt. Ltd.
