2.	No clarification to the observation on Point No. 7 has been given with the reply	The area specified for the said project cannot be reduced as the components like Bus Stand, Workshop, Parking and Office Building has been proposed under Sub-Depot and Bus Stand at Khundian.
3.	W.r.t. point no. 8 no detail regarding possibilities to explore the alternative sites has been given. Further, no list of trees to be retained in open area and yard etc. is given with the reply. A list of trees coming in the alignment of the project site has been furnished with the reply which is not required.	A Certificate regarding alternatives explored has been uploaded on the portal and also attached with the proposal folders. Also, a list of trees to be retained in open area and yard has already been prepared and submitted to your good self. A copy of the same list is hereby attached with this reply for further necessary action.
4.	A certificate showing the exact distance of the project site from notified ESZ of Pong Dam WLS from concerned DFO has not been found attached with the reply.	Pertains to DFO Office
5.	No Muck dumping certificate & undertaking as desired by the Govt. of India on Point No. 11 found attached with the reply.	Muck Management Plan and Undertaking for dumping of muck has been uploaded and attached with the proposal folders.
6.	All records and annexure of consultation and proceedings of FRC and Gram Sabha of all the concerned villages are not found attached with the reply.	Complete FRA certificate with all the proceedings has been uploaded and attached with the proposal folders
