Subject:- Case regarding sanction for tubewell pipe crossing over the Kaluana Disty at RD 57000 village Lakkarwali / Gadrana District Sirsa (On the cost of applicant)

Ref:- Your office letter No. 2096/S-W dated 09/12/2019

As recommended by you vide letter quoted under references, the tubewell water pipe crossing over the Kaluana Disty at RD 57000 is returned herewith duly approved with the following conditions:-

1. The pipe crossing shall have to be removed immediately at any time within a 24 hour notice without assigning any reason in public interest for repair of channel and or due to some other requirements for proper running and maintenance of the channel etc.
2. In case the pipe crossing is not removed/ dismantled by the owner within the stipulated period and in case of emergency, the pipe crossing shall be dismantled by the department without any notice or assigning any reason.
3. This permission / approval shall not confer upon the owner of the tubewell crossing any kind of right to use/ right of way over the channel or along the channel at any stage.
4. This permission/ approval of the pipe crossing shall not confer on the owner any entitlement to claim any kind of damages or compensation, What so ever, on account of removal of the pipe line crossing in the manner outlined as aforesaid.
5. An affidavit according to Annexure -A of the latest Govt. Policy endorsed to your office vide T/O letter No. 10557-60/13-W dated 28.7.2017 be got from the applicant before crossing of pipe line.
6. The processing fee as per norms/ rules may be got deposited in Govt. chest from the applicant before taking any action.
7. The work should be carried out at the cost of applicant.
8. No masonry work is to be allowed within the Govt. land boundary on left side and right side from the center line of the channel. Diggi, if any required, should be constructed in private land only.
9. Metal pipe should be used for crossing over the channel.
10. The condition regarding minimum distance of tubewell from Canal should be strictly adhered as per Canal Act.



11. Safety of the channel should be ensured.
12. All department formalities as per draft policy/ guideline should be observed before start of work
13. The pipe shall have to be removed immediately at any time, in case of commercial use of pipe.
14. The pipe line may be laid in the presence of JE incharge / SDO incharge.
15. All fundamental rights in respect to the canal land will remain with Haryana Irrigation & W.R. Deptt Panchkula.
16. All ownership of land will remain with Irrigation Department.
17. In case of any aeventuality during the course of execution of work, the responsibility will rest upon applicant.
18. An agreement shall be executed by XEN on behalf of Govt. of Haryana with applicant stipulating all the terms and conditions for safeguard the state interest.
19. The tubewell water pipe X-ing will be used for tubewell water crossing only by the applicant as applied.


(Complete case pipe crossing
