**PROCEEDINGS OF THE PUBLIC HEARING HELD ON 04.04.2013, AT 11.00 AM IN THE OPEN PLACE OVER KHATA NO.55, PLOT NO. 888 OF KALIAPANI VILLAGE IN FRONT OF MAIN GATE OF M/S BALASORE ALLOYS LIMITED FOR ENHANCEMENT OF PRODUCTION CAPACITY OF CHROMITE ORE FROM 0.42 MTPA TO 0.60 MTPA AND CHANGE OF TECHNOLOGY FROM OPEN CAST TO UNDERGROUND OVER AN AREA OF 64.463 HA. AT KALIAPANI VILLAGE, UNDER SUKINDA TAHSIL OF JAJPUR DISTRICT.**

The public hearing in respect of the project proposed by Kaliapani Chromite Mines of M/s. Balasore Alloys Ltd. for enhancement of production of chrome ore from 0.42 MTPA to 0.60 M TPA along with change of technology from open cast to underground over an area of 64.463 Ha. at Kaliapani village was held on scheduled date & time in the open place over Khata No. 55, Plot No.888 of Kaliapani village in the district of Jajpur with reference to:

- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006
- II. Interim Operational Guidelines till 13<sup>th</sup> September 2007 in respect of applications made under EIA-1994

**The panel consisted of the following members:**

1. Sri Chakrayudha Hota, Additional District Magistrate, Kalinganagar, Jajpur
2. Sri Puskar Chandra Behera, Asst. Env. Scientist, Regional Office, State Pollution Control Board, Cuttack.

Sri Chakrayudha Hota, Additional District Magistrate, Kalinganagar, Jajpur supervised & presided over the public hearing process and assisted by Sri Puskar Chandra Behera, Asst. Env. Scientist, Regional Office, State Pollution Control Board, Cuttack, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, Sri Puskar Chandra Behera, Asst. Env. Scientist, State Pollution Control Board, Cuttack welcomed the panel member and the assembled public, print & electronic media and then he gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006, and interim operational guidelines till 13<sup>th</sup> September 2007 in respect of project proposed by Kaliapani Chromite Mines of M/s. Balasore Alloys Ltd. for enhancement of production of chrome ore from 0.42 MTPA to 0.60 MTPA along with change of technology from open cast to underground over an area of 64.463 Ha. at Kaliapani village in the district of Jajpur

Welcoming the public the Additional District Magistrate, Kalinganagar, Jajpur explained that, views, comments, objections and opinions of the public is necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation about various aspects of the expansion project to be undertaken for better awareness of the public. Sri Basanta Kumar Parida, Asst. General manager, Kaliapani Chromite Mines of M/s. Balasore Alloys Ltd. on behalf of the project proponent addressed the committee members and assembled public and made a brief presentation about the salient features of the proposed expansion project, environmental

management, pollution control measures, waste management, afforestation programme and various other peripheral development activities envisaged in the proposed project.

Then the public were invited to present their views about the proposed project on environmental considerations.

The views expressed by various speakers are as follows:

**1. Duryodhan Mahanta, Kalarangiatta:**

Welcoming the expansion and underground mining proposal of Kaliapani Chromite mines of M/s Balasore Alloys Ltd. he told that due to underground mining there will be no tree falling and less environmental impact on surrounding environment. He requested for development of health and communication of the region. He also requested for construction of a college building as there is no college in the area. At the end he expressed his positive views for environmental clearance of the mine.

**2. Sarata Nayak, Kankadapal:**

Welcoming the panel and gathering he told that 7-8 mines are operating in this region and if the mines are stopped operation about 15,000 people will be suffered for work and their livelihood. He informed that pollution potential will be less due to underground mining and requested the gathering to support the expansion proposal of the mine for generation of more employment opportunity for the unemployed youth of the area. At the end he expressed his support for the expansion proposal of the mine and hope for benefit of the poor villagers due to underground mining.

**3. Bimalendu Beura, Sukinda:**

He expressed his unhappiness for degradation of forest due to mining activity in the past periods. According to him he is not opposed the underground mining but the mine authority has not contributed from their profit for developmental work of the area during the last thirteen years. He asked the mine authority to clarify the amount contributed for this region. He also said that road condition of the mining area is very poor and the mine authority has not given attention for water sprinkling. He also told that the mine is discharging chromium contaminated mine drainage water to the nearby Damsala nalla for which people are suffering from diseases. He expressed his views about less afforestation, inadequate Corporate Social Responsibility work of the company.

**4. Raichran Mohanty, Sukinda:**

During his deliberation he told that M/s Balasore Alloys has not done any things for the surrounding villagers. According to him deliberation of mines authority regarding peripheral work is not true. At the end he said that mine authority should operate the mine after carried out the developmental work like education, health services, communication facilities and drinking water supply to the nearby poor villagers. He gave a written representation to the panel.

**5. Bharat Chandra Mahanta, Kaliapani:**

Welcoming the expansion proposal and open cast to underground mining of Kaliapani Chromite mines he said that there will be less impact on environment due to underground mining.



He told that the company is providing drinking water to the people of Mahantasai and Mundasai of Kaliapani village. He requested to provide drinking water through over head tanks to the villages. At the end he supported the proposed expansion and underground mining of Kaliapani Chromite mines of M/s Balasore Alloys Ltd.

**6. Ganeswar Acharya, Sukinda:**

Welcoming the panel and assembled gathering he told that out of 64 ha. of mining lease about 50 Ha. area has been exhausted by open cast mining and the rest 14 Ha. land is utilized for washing plant, weigh bridge and office purpose by the mine. According to him necessary depth of mining and height of the over burden dumps already carried out by the mine authority and now it is time for underground mining. He said that pollution potential is very less in underground mining in comparison to open cast. He expressed that 12 mines are operating in the area and they have installed individual Effluent Treatment Plant for their mine drainage water. The treated water is discharged to Damsala nalla. According to him if one ETP of a mine will defunct then the untreated water will contaminate the entire Damsala water. He proposed for a common ETP for the 12 mines and the treated wastewater may be discharged to the Damsala nalla. He expressed his views for common blasting hour for 12 mines instated of different timing for less time exposure of the nearby villagers. At the end he supported the expansion proposal of the mine and urged for developmental work for the people of the region.

**7. Gauranga Patra, Kaliapani:**

He gave his speech by supporting the Expansion and underground mining of the mine.

**8. Debendra Parida, Kankadapal:**

He welcomed and supported the proposed expansion proposal and underground mining of Kaliapani Chromite mines of M/s Balasore Alloys Ltd.

**9. Saluka Anolya, Kaliapani:**

He welcomed the proposed underground mining and expressed his support to the project due to less adverse impact on environment and prevention of deforestation.

**10. Srinibash Acharya, Sukinda:**

He expressed his displeasure due to deforestation of the area due to mining activity. He also expressed his unhappiness for less employment in the mine of local people.

**11. Nalini Devedi, Sukinda**

Welcoming the panel he expressed his views that ten thousand people are working in the Sukinda mines from nearby villages and fifty thousand families of the mine workers are maintaining their livelihood. At the end supported the proposed underground mining.

**12. Laxman Mahanta, Kherakhi, Dhenkanal:**

He told that the local villagers are facing lot problems due to air pollution and the mine has not given attention towards development of the area and employment to them. He demanded for employment in the mine.

**13. Ramakanta Mohanta, Chotaliposi :**

Welcoming the gathering he informed about the less adverse impact on Environment in underground mining and suggested for adequate measure to mitigate depletion of ground water table.

**14. Laxman Tudu: Malia, Sukinda**

He expressed his concern over ground water table depletion in the area and point out regarding no arrangement for irrigation facilities. The mine has not given attention to the unemployment young mass and not supplied drinking water for the poor villagers of the mining area.

**15. Satya Ranjan Mahanta, Raonsala:**

He supported the expansion and underground proposal of the mine.

**16. Santosh Mishra, Sukinda:**

He asked the project proponent to express their views regarding developmental work for the region, arrangement of irrigation facility for agricultural land, providing Medical facility and development of communication facility to the district administration.

**17. Sri Champak Mohapatra, Sukinda**

He objected the proposed expansion of mining project and gave representation to the panel.

**18. Gitanjali Mohanta, Sukinda**

She express her concern over less CSR developmental work by project proponent. He demanded to provide drinking water, health services and employment to the unemployed youth mass. She also demanded to provide treated mine water to the farmers for irrigation instead discharging to Damsala nalla.

**19. Sri Majhia Tudu, Sukinda**

He objected the proposed expansion mining project.

**20. Sri. Bidyadhar Mohanta, Kalarangi atta**

He expressed his unhappiness for discharge of contaminated mine drainage water to their agricultural land and nearby Damsala nalla.

**21. Smt. Malay Manjari Mohapatra, Bandhagaon**

She expressed her concern happening of earthquake, water pollution and depletion of ground water level due to underground mining. Also pointed out less plantation and CSR activities of project proponent. She suggested to give attention towards agricultural development and medical facility and supply of drinking water.

**22. Smt. Swapna Behura, Sukinda**

She expressed her displeasure regarding depletion of ground water table and scarcity of drinking water in the Sukinda region. She told that due to mining activity and discharge of mine drainage water to nearby Damsala nalla people are suffering from different diseases. She also told that the mine is operating since last 13 years and no CSR work under taken by Project proponent.

**23. Sri Mrunal kanta Rana, Bambilo**

He expressed his unhappiness towards CSR activities of the project proponent and objected the underground mining.

**24. Sri Jayasingh Sardar, Kalarangiatta**

He welcomed the proposed expansion proposal of Kaliapani Chromite mines of M/s Balasore Alloys Ltd. He told that the mine has done developmental work like supply of drinking water, education to the tribal children and employment to local people. At the



end he supported the project and demanded for emphasis on educational development in periphery area and more plantations.

**25. Sri. Nilakantha Mohanta, Bengadia.**

He suggested to take measure for mitigating depletion of water level due to underground mining, Providing Drinking water facility to villagers, increasing the nos. of employment from local area. He also demanded to set up an ITI/Diploma or engineering education institute in periphery area so that student of local area will get chance to make their career in technical profession.

**26. Sri Tapan Kumar Nayak, Nuadiha, Sukinda**

He expressed his dissatisfaction about less CSR activities undertaken by project proponent.

**27. Sri Chanchal Mohapatra, Sukinda.**

He expressed his dissatisfaction with project proponent

**28. Sri Pratap Chandra Mohanta, Bandhgaon.**

He expressed his concern about ground water level depletion, water pollution due to mining activity and also informed about less employment from local area.

**29. Sri. Dilip Kumar Mohanta, Ransola**

He told that there will be more water pollution due to underground mining and also informed that project proponent is not under taken adequate CSR activity.

**30. Sri Ramdas Tudu, Kiajhar, Sukinda**

He welcomed the proposed underground mining project and told that if mine will enhance the production then more employment will be generated for the local villagers. He urged for more overall development like Health, education in peripheral villages by the project proponent.

**31. Sri Shakila Hansda, Kaliapani.**

He welcomed the project for overall prosperity of locality.

**32. Smt. Jilita Munda, Kalipani.**

She raised her satisfaction for enhancement of production and demanded at project proponent for more care towards water pollution. She also suggested to make arrangements for use of treated mine water for irrigation in agriculture field so that farmers will be benefited. She also urged for more work to be done for Health and educational development in periphery villages.

**33. Smt. Ranuka Choudhury, Chingudipala.**

She welcomed the proposed expansion proposal of the Kaliapani Chromite mine of M/S Balasore Alloys Ltd.

**34. Smt. Susama Nayak, Ransola**

She welcomed and supported the proposed expansion proposal of the mine.

**35. Sri Pradipta Ku Patra, Kankadapal, Sukinda.**

He expressed his dissatisfaction over peripheral development activities undertaken by Kaliapani Chromite mines of M/S Balasore Alloys Ltd. highlighting the scarcity of Medical and Educational facilities.

**36. Sri Nimalendu Behura, Sukinda**

He expressed his objection to underground mining project.

**37. Sri Ranjan Kumar Sahoo, Jajpur**

He welcomed the proposed mining project and requested for more developmental work in peripheral villages. He also demanded to set up one 170 bedded hospital for better medical facility and one Industrial Training Institute for local area.

**38. Abhimanyu Nayak, Sukinda**

He registered his name but not deliberated his speech.

**39. Sri Jamshed Ali Khan, Sukinda**

He objected the project with written statement.

**40. Sri. Trilochan Barik, Ragada, Kaliapani**

He welcomed the project with expressing his satisfaction on overall development of periphery area undertaken by Kaliapani Chromite Mines of M/S Balasore Alloys Ltd.

**41. Sri. Shambhunath Mohanta, Raonsol.**

He expressed his support towards the proposed expansion and underground mining project.

**42. Sri, Biswajit Mohanty, Ransol**

He expressed his support for the project for concern about less environmental impact due to underground mining and more employment opportunity for local people.

**43. Sri. Biren Samal, Ransol**

He welcomed the project and expressed his concern for overall development of peripheral area due to underground mining and production enhancement.

**44. Sri. Gouranga Ch. Nayak, Kaduabandi**

He expressed his support for the proposed mining project and demanded for more employment of local peoples and more CSR activities.

**45. Sheik Jhangir Khan, Sukinda**

He welcomed the project and demand for better medical facility to peripheral villagers.

**46. Sri. Santosh Ku Parida, Kankadpal**

He expressed his support for the project and demanded for more employment of local people, provision of good medical facility, more developmental work towards education in local area. He also suggested to develop an herbal garden to save the medicinal value of present flora found in local area. He also suggested making arrangement for better irrigation facility to agriculture land so that farmers can be benefited.

**47. Sri Trilochan Deo, Ransol**

He welcomed the project and urged for more developmental work in periphery villages.



**48. Smt. Sushila Bindhani, Kalarangiatta**

She expressed her support to the project highlighting the benefits like more employment opportunity for local people. She requested to the mine authority to engage the local people in pay roll instead of contract job. She also suggested the project proponent for up gradation of wastewater treatment technology before discharge to Damsala nalla. She urged for construction of check dams over the nalla for irrigation of agriculture land.

**49. Sri Jagatjiban Ram Hemram, Katepurti Nagar**

He supported the project with expression about concern over overall development of peripheral area and hopes for more developmental work.

**50. Sri. Sanjay Kumar Parida, Kankadpal**

He expressed his support towards the project and demand for more CSR activities like health and communication. He urged to establish a school (Shisu Mandir) for better children education.

**51. Sri. Anil Ku Siya, Kaliapani**

He expressed his support for the expansion proposal of the mine and given a written representation.

**52. Sri. Bipin Bihari Jena, Haripur**

He welcomed the proposed mining project and suggested for adequate measures for control of pollution.

**53. Sri Debraj Mohanta, Kaliapani**

He expressed his support to the project and demanded for more attention of project proponent towards development of education facility in local area.

**54. Sri Jaganath Mohanta, Chngudipala**

He welcomed the project and requested to make proper plan for monitoring of environmental impact due to underground mining and requested for drinking water supply.

**55. Sri Balaram Das, Ransol.**

He supported the project and demanded for providing better medical facility to villagers of periphery area.

**56. Sri. Babuli Parida, Kankadpal**

He appreciated the road development work done by M/S Balasore alloys Ltd. and expresses his hope for more such developmental work from project proponent.

**57. Sri Sanatan Mohanta, Chingudipal**

He supported the project due to his satisfaction on overall developmental work done by proponent.

**58. Sri Ramei Hansda, Kalaipani**

He registered his name but not deliberated speech.

**59. Sri Kapila Behera**

He registered his name and not deliberated speech.

## 60. Sri Amalendu Behura, Sukinda

He expressed his unhappiness regarding discharge of Chromium contaminated mine drainage water to nearby Damsal nalla and depletion of ground water in the area. He told that water pollution is mainly due to mining activity and Damsal nalla is more affected. People depending upon nalla are suffered from various water born diseases. He also informed about deforestation done by project proponent during mining activity. At the end he invited a group of people for agitation in front of the panel.

Though persons of SI No.61-65 registered their names but they were not given their deliberation.

The Panel has received 269 (Two hundred sixty-nine) nos. of written representations during the hearing which are enclosed herewith in original.

### Observation:


Speaker No.60 Sri Amalendu Behera, at the end of his deliberation he called a group of people including those who had already given their deliberation on the proposed expansion mining project of M/s Balasore Alloys Ltd. A group of people were given slogan against the project proponent and protested the public hearing process of the mine. At this point of time the panel members try to pacify the agitator and assured the public that all the views of the 60 speakers on environmental issues will be forward to MoEF Govt. of India but even after that the agitators did not stopped their agitation.


The overall opinion of the public about the expansion project was favourable. However, the local people have some aspirations as laid down in their deliberations.

Sri Puskar Chandra Behera, Asst. Env. Scientist, Regional Office, State Pollution control Board, Cuttack & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers.

Mr Shankar Gangopadhyay, Vice President (Mines) on behalf of project proponent, M/s Balasore Alloys Ltd replied the points raised by the public to safeguard the environment, to create job opportunity to the local people and to take up the peripheral development on the issues raised by the public. But the agitators did not allow him to complete his deliberation and gave slogan in high voice and the meeting is ended at about 2.45 P.M.
