Sub- Proposal for grant of access permission to a retail outlet of M/s HPCL at km 180/949 to 180/994 (LHS) of Nagaur to Bikaner road, NH-89 (New NH-62) (Khasra No.525/128) at Village-Barani, Tehsil & District-Nagaur in the state of Rajasthan.

Ref: 1.This office letter no. RW/JAI/RJ/PS/2020/1260/2557-58 dated 20.07.2020. 2.EE PWD NH-Div-Nagaur letter no.375 dated 30.07.2020.

Sir,

An Online proposal on above mentioned subject proposal was received from M/s HPCL Ltd & recommendation and certification of Check List, Layout Plan, Drainage Plan and Location Plan by EE PWD NH-Div Nagaur (Raj) the proposal is examined in this office in accordance with Ministry's Guidelines/ Norms issued vide letter No. RW/NH-33023/19/99-DO-III dated 24th July, 2013 and letter No. RW/NH-33023/19/99-DO-III dated 25.08.2014 and letter no. RW-NH-33032/01/2017-S&R(R) dated 26th June,2020 the proposal is granted "in-principle" approval and a provisional NOC subject to following conditions. One set of the original Layout plan, duly signed by the Regional Officer (Civil), Jaipur is enclosed. One set of Layout plan, has been retained in this office.

- (a) The Oil Company shall construct the fuel station along with its access as per approved Layout drawings and provide drainage arrangement as per the approved drainage plan at their own cost within 6 (six) months of the issue of this Provisional NOC. After the construction as per approved drawings and to the satisfaction of Highway Administration, the final approval may be given within 30 days of the receipt of the communication from the applicant about the completion of construction work and License Deed may be signed by the Highway Administration. In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.
- (b) The applicant should adhere to the undertakings given by them in compliance to para 7 to 10 of Appendix-I to Ministry's letter No. RW/NH-33023/19/99-DO-III dated 24th July, 2013. It shall be ensured by the concerned Executive Engineer/Project Director, NHAI that the -undertakings made by the applicant are complied in all respects. Any discrepancy would lead to violation of the Ministry's guidelines and the approval extended shall stand cancelled.
- (c) Concerned Executive Engineer/Project Director, NHAI shall examine the road safety conditions during/consequent to construction of approaches.

- In case of any adverse conditions, the matter may be reported to this office. Compliance to the approved drawings and other conditions are to be ensured by them.
- After obtaining "in-principle" approval, the oil company/owner shall be responsible for construction and maintenance of acceleration/deceleration lanes, (e) service lanes, channelizers, drainage arrangement, drinking water and toilet facilities in accordance with the approved drawing/lay out plan and specification conforming to the norms at his own cost in close co-ordination with Project Director/Executive Engineer & concessionaire.
- There should be a Public Drinking Water Facility and a Public Toilet Facility in (f) the fuel station. The drinking water and toilet facilities shall be accessible to public round the clock. In order to inform the public about these, a display board showing availability of such facilities shall be installed before the entry to the fuel station. Toilet block has been prepared as per Ministry's guideline no. RW/NH-33044/05/2018/S&R (P&B), dated 18.01.2018. In this regard, a standard layout plan for toilet block is enclosed herewith.
- Oil Company will also ensure video recordings before and after completion of work and CD of the above recording shall be submitted at the time of signing of (g) License Deed.
- Ministry's revised guidelines vide circular no RW-NH-33032/01/2017-S&R(R) dated 26th June,2020 Demand Draft for Rs. 2,50,000/-as one time License Fee (h) with 5 % increase in every calendar year payable to RPAO (NH), MoRTH, Jaipur has not been submitted. Same should be submitted at the time of Final NOC.
- The BG shall be released by the Highway Administrative within 30 days of the grant of regular access permission. In case the access construction is not (i) completed even within extended period, the Highway Administration may encash the bank Guarantee(as per revised Ministry's circular no. RW-NH-33032/01/2017-S&R(R) dated 26th June,2020).
- This issues with the approval of Regional Officer (Civil), MoRTH, Jaipur.
