- 3. Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 28/11/2021 to the Board.
- 4. Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution)Act, 1981 from the Board.
- 5. It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- 6. Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

Specific Conditions:

- 1- Petrol Pump shall ensure adequate plantation and green belt 20 meter wide or 33% of total area. As per directions issued vide letter no. G26524/220/2018/1 date 12-02-2018 of head office U.P. P.C.B.Lucknow within its premises.
- 2- Petrol Pump shall comply with various Waste Management Rules as notified by MoEF & CC i.e. Plastic Waste Management Rules, 2016, Solid Waste Management Rules, 2016, Hazardous and Other Wastes (Management and Trans boundary) Rules, 2016, E-waste (Management) Rules, 2016, Construction and Demolition Waste Management Rules, 2016
- 3- Installed Proper Maintain Air pollution control system and ensure the emission norms.
- 4- Make proper arrangement for storage of solid waste.
- 5- Petrol pump ensure the compliance of Directions given by the Board time to time.
- 6- DG Sets installed in factory premises will operated as per norms.
- 7- Raw material lying in the factory premises covered and water sprinkled time to time so that the particulars matters are not suspended in atmosphere.
- 8- This NOC will be automatically rejected on receiving of any complaint against petrol pump.
- 9- Point wise compliance report of this NOC must be sent to this office within one months.
- 10- Rain water harvesting system must be installed in premises unit.
- 11- Industrial effluent should not be discharged out of premises in any condition.

Please note that consent to Establish will be revoked, in case of, non compliance of any of the above mentioned conditions. Board reserves its right for amendment or cancellation of any of the conditions specified above. Industry is directed to submit its first compliance report regarding above mentioned specific and general conditions till 28/12/2019 in this office. Ensure to submit the regular compliance report otherwise this Consent to Establish will be revoked.
