1	In repy of point No. 4 of EDs, it is mentioned that component wise breakup has now been revised at B. 2.4 part-I online. Persual the revised component wise breakup shows that 0.14 ha forest land is required for the road and 0.0525 ha is required for muck dumping this making the total requiredment of forest land as 0.1925 ha. However, as per land schedule uploaded at sr. No. 6 additional document part Ionline, the total 0.1925 ha forest land is required for the construction of road may clarify this point and revise the relevant documents if there are changes.	Muck dumping area is included in Civil and which is shown in B2.4 part I online. No Document are change. Civil land 200 mtr = 0.1400 ha Muck dumping 75 mtr - 0.525 ha Total = 275 mtr -0.1925 ha. 3	In the recommendation of the State Nodal Office uploaded at Part 16 Part II online the area is mentioned as 2.61 ha instead of 0.1925 ha.	Related to DFO.
