The promoter shall maintain a website which shall exhibit the details of all approvals taken by with regard to any project undertaken by the promoter, which include this certificate, approved layout plans, payment terms etc. or any other documents/information which requires to be disseminated to the prospective buyers.
- 7. The competent Authority has the right to withdraw or cancel the certificate at any time during the tenure of registration, if it is found that:
 - The promoter has given any wrong information in his application for registration.
 - The promoter has been adjudicated as insolvent or is undischarged insolvent or
 - c. The promoter has been convicted under the act or any other law relating to construction or use of premises.
 - d. The promoter has contravened any of the terms & conditions of this certificate or any of the provision of the Act or Rules made thereunder or any other Law enacted by the Central or the State Government.
