Earlier, Government of India, MoEF & CC, New Delhi had accorded Stage-II (final approval) for diversion of 221.80 ha of forest land under Forest (Conservation) Act, 1980 for the project vide ref (1). Accordingly, Government of Karnataka had issued orders vide ref (2). Government of Karnataka in the said order had stipulated / prescribed the lease period as 15 years.


In this regard your attention is also invited towards letter of Government of India at ref (3) and further correspondence made by this office at ref (4). However, the information sought vide ref (3 & 4) is yet to be complied with / received in this office.

M/s Wind World (India) Limited vide letter at ref (5) have intimated that they are paying / paid lease rent (part payment) of Rs.5.08163 lakh through five separate DDs dated 18 & 19-06-2018. In this regard your attention is drawn on the following issues.

- 1) Lease Rent can be collected only for the period of currency of FC lease and not beyond, until the lease is duly renewed under Forest (Conservation) Act, 1980.
- 2) Lease Rent can be collected only from the FC lease holder in whose favour the forest land has been diverted under Forest (Conservation) Act, 1980 and with whom the Lease Agreement has been signed.
- 3) For delayed payment, interest needs to be charged for the period of delay.
- 4) The FC lease holder cannot be allowed to operate and possess the leased forest land unless the said lease holder has duly submitted FC lease renewal application.

In view of above, you are hereby instructed to examine the issue accordingly and submit an Action Taken Report to this office through the Chief Conservator of Forests, Ballari Circle, along with information / details of payments made by User Agency against the stipulations in the enclosed format.
