


**Name of Work:- Construction of Helipad at Shawala, Tehsil Nerwa District Shimla HP.**

**CALCULATIONS OF THE NET PRESENT VALUE (NPV) OF THE FOREST LAND  
BEING DIVERTED**

In consonance to the order dated 28/03/2008 of Hon'ble Supreme Court of India in writ petition (Civil) number 202 of 1995, the Net Present Value of the forest being diverted is calculated as under:-

The Ecological Class V includes the forest type found in the forest diverted. The average density of the forest is 0.025 i.e. open forests

The Hon'ble Supreme Court has fixed NPV of Rs.6,57,000/- per hectare for class V eco-value, open forest hence the total value works out to be Rs.**649707/-** for 00-98-89 hac of forest land being diverted.






