ORDER

Whereas, sanction / approval has been accorded to the CA Plan against proposal No: FP/ JK/ VELEC/ 153465 / 2022 of Marwah Forest Division vide No: CCFJ/Plg/22-23/44/369-72 dt 18.05.2022; and


Whereas, the CF Chenab / DFO Marwah vide above references conveyed that IRO Jammu has made observation and raised EDS which has been conveyed by the PCCF office vide No: PCCF/FCA/3477-78 dt 30.10.2022 that 1 hectare area out of proposed 6 hectares for undertaking CA is moderately dense forest and approximately 2.90 hectares is under mature / middle height trees / vegetation as per Google Image. Accordingly, the DFO Marwah has submitted revised CA Plan which has been duly recommended by the CF Chenab Circle.

In view of the above, the revised work proposal for Compensatory Afforestation to be done in lieu of diversion of 2.982 hectares of forest land in Marwah Forest Division for "Laying of New 11 KV Line from Dangdoro to Sewarbhatti" to the tune of Rs. 12.50 lakhs, prepared and submitted by the DFO Marwah Forest Division, duly recommended by the CF Chenab Circle, Doda, is hereby approved / sanctioned, as per the detail given below:-
