Sub: Coimbatore City Municipal Corporation - Alienation of Land, measuring 1.53 Acres (0.62.0 Hecteres) of the Forest Assessed Waste Land - bearing S.F.No.1044/4 & 1044/5 of Madukkarai Village, Madukkarai Taluk, Coimbatore District belonging to the Forest Department to the Coimbatore City Municipal Corporation to the existing burial ground in and adjoining the above mentioned Forest Land - for the purpose of carrying out burial ground development and improvement works - By exchange of double the extent of Revenue department land for the purpose of afforestation – Requisition proposal submitted – Regarding.

I am to state that At present the burial ground is functioning at SF Nos. 1045 Madukkarai Village, Madukkarai Taluk, belonging to the National Highways department measuring 3.03.3 hec. and a part of the Forest Department land mentioned as above and that it is used by the general public hailing from Kovaipudur, Sugunapuram, Milekal and Madukkarai areas.

In as much as the above mentioned existing burial ground is not able to cope with the imperative needs of the fast growing Population, the Corporation proposes to alienate the land measuring 1.53 acres (0.62.0 Hec) of the Forest Assessed Waste Land bearing S.F.No.1044/4 & 1044/5 of Madukkarai Village, Madukkarai Taluk, Coimbatore District belonging to the Forest department to the Coimbatore City Municipal Corporation for the purpose of carrying out essential development and improvements to the existing burial ground.

In this connection it is stated that the public have been experiencing lot of difficulties for the past 25 years for want burial ground specially for Christians and that numerous representations are being received from the Public frequently demanding the burial ground.

As per the settled principles in force, while allotting the Forest Land for non-forest activities, alternative land to an extent of double the extent of forest land is required to be allotted to the forest department for the purpose of afforestation.

Accordingly, the Coimbatore Corporation is forwarding the present proposal to allot the lands belonging to Revenue Department situated at Madukkarai Taluk, Thenkarai Village S.F.No.499/3 an extent of 1.24.0 Hecteres. (i.e. Double the extent of Forest land measuring 0.62.0 hectares) in exchange of the above Forest Lands situated at Madukkarai Village.

In the light of the above facts and circumstances, the imperative need for allotting more space for the development of burial ground together with carrying out essential requirements has arisen now.

I therefore request that the land alienation proposal for allotting space to the burial ground as mentioned above may please be considered in the proper perspective and favourably and that necessary orders in this regard may please be issued at the earliest. The connected village records, FMB and other records are enclosed In this regard for your positive consideration of the proposal.
