




यह परियोजना, मै0 एस्सार आयल लिमिटेड नोएडा द्वारा ग्राम आजमगढ़ उर्फ रतनगढ़ तहसील चोंदपुर जिला बिजनौर की खसरा संख्या-147 में पेट्रोल/डीजल पम्प के निर्माण से संबंधित है, जो नहतौर-नूरपुर-अमरोहा-जोया मार्ग किमी0 26.400 की दायी पटरी पर पेट्रोल/डीजल पम्प का निर्माण कार्य प्रस्तावित है। प्रश्नगत पेट्रोल/डीजल पम्प के निर्माण हेतु स्थल का संयुक्त निरीक्षण दिनांक 14-10-2015 को क्षेत्रीय वन अधिकारी चोंदपुर एवं उप प्रभागीय वनाधिकारी बिजनौर तथा याचक विभाग के साथ किया गया। मौके के निरीक्षण से यह स्पष्ट है कि पेट्रोल/डीजल पम्प के प्रवेश एवं निकास मार्ग में वृक्ष बाधक नहीं हैं। प्रवेश एवं निकास मार्ग के मध्य 05 वृक्ष खजूर अवस्थित हैं। इस परियोजना के 0.0751 हेक्टेयर वन भूमि पर लोक निर्माण विभाग, बिजनौर का स्वामित्व है तथा वन विभाग का संरक्षित वन क्षेत्र है। सम्यक विचारोपरान्त पाया गया कि प्रश्नगत संरक्षित वन भूमि के अतिरिक्त कोई विकल्प नहीं है और मांगी गयी संरक्षित वन भूमि योजना की आवश्यकता को देखते हुए न्यूनतम है।


