**FOREST LAND PROPOSED FOR DIVERSION:** 8.161809 Ha.

**FULL TITLE OF THE PROJECT:-** Diversion of 8.161809 Hectare forest land for laying of Drinking Water Distribution Pipeline (Total Km 96.30) under Jakhlaun Birdha, Dhorra Balabehat, Kadesara Kalan and Mau Group of Village Water Supply Scheme, District- Lalitpur (U.P.).

### **MUCK DISPOSAL PLAN**

It is to certify that there shall be no any type of earth excavation in diversion of 8.161809 Hectare Forest Land under Social Forestry Division, Lalitpur for laying of Drinking Water Distribution Pipelines for non-forestry purpose to provide drinking water.

Hence there is no proposal of muck disposal permissible for this project.

Disposal/Management Plan

While preparing FCA case, if there is any activity in the project which involves digging of land, muck disposal/management plan has to be prepared.

- 6 Photograph & carrying capacity of proposed dumping site (muck disposal site). N.A.
- 7 Development of dumping site-construction of retaining walls and other structure as requirement of the site. The objective is to completely stop rolling down of the muck. N.A.
- 8 Rehabilitation of dumping site like leveling, planting of grass, shrubs and tree species after laying of Drinking Water Distribution Pipelines under Jakhlaun Birdha, Dhorra Balabehat, Kadesara Kalan and Mau Group of Villages Water Supply Scheme District- Lalitpur (U.P.) N.A.

Cost to be incurred on the above activities has to be given component wise, details of dumping site including length, width and height of structures to be exacted must be mentioned.

**Undertaking by the Construction Unit, Uttar Pradesh, Jal Nigam, Donda Ghat, Lalitpur, Lalitpur ,User agency/department has to be given to the effect that:**

1. Muck management plan will be implemented by the user agency and in case of non-implementation of the plan, they will be liable to penalty /action at their cost.
2. The proposed dumping site is located away from river/stream/nala.
3. There are no muck disposal will be produce in huge quantity, where as some quantity of muck disposal will be produce, that will be reclaimed/disposed in leveling of Earth surface etc.
