ORDER No. _____/Mines Dated. _____

Sub:- Grant of surface right over an area of 15.068 hectares within the lease hold area over 66.368 hectares in village:- Joruri for Iron & Manganese ore under Champua Sub-division of Keonjhar District in favour of Sri Niranjan Patnaik.

Permission is hereby accorded to the acquisition of surface right over an area of 15.068 hectares in village:- Joruri (forest land) in favour of Sri Niranjan Patnaik for Iron and Manganese ore subject to the following conditions,

1. The lease hold area is for Iron and Manganese ore only. As soon as any other minerals is discovered in course of mining operation in the area covered by this permission, the Lessee shall report the fact to the Collector as required under clause 9 of part - VII of the lease deed.

2. As per clause 5 of part - III of the lease deed, the Lessee shall not work within 50 metres of any Railway Line, public road, national highway, canal, building without specific permission of the Collector, Keonjhar.

3. Surface rent @ Rs.10.00 per hectre per annum shall be paid from the date of occupation of the area and so amended from time to time.

4. The legal status of the land will remain unchanged.

5. Mining lease over 66.368 hectares for a period of 20 years is permitted subject to use of 15.068 hectares in the first five years of the lease i.e. 1991 - 95.

6. Compensatory afforestation and reclamation plan to be carried out as per the scheme at the cost of the user agency.

7. For breaking up of the balance forest land beyond 1995, fresh proposal for de-reservation should be submitted to the concerned Ministry for approval.

8. Dumping of waste should be done in the existing six small abandoned quarries within the lease hold area.

9. The working of the Mines (Mining operation) will start after the clearance of the area & possession given by D.F.O.(T), Keonjhar.

10. The Lessee will be responsible for any irregularity within and around 20 chains of the area.

11. The applicant will post permanent pillars in the demarcated area for which surface right is given

12. This permission is granted subject to other restriction and conditions imposed in the lease deed.

13. The permission may be withdrawn by the undersigned at any time without assigning any reason and no compensation shall be paid for any loss or damage caused to the Lessee for such withdrawal.
