

1	It has been observed that the total forest area sought for non-forest use is 81.1717 ha as per details submitted on Parivesh Portal (Part-1) whereas the final recommendations is for 78.3877 ha. The involvement of forest area need to be corrected by the User Agency on the Parivesh Portal (Part-1).	Nodal Officer FCA o/o PCCF has been authorized to edit the area on the portal. However, area correction has been made in all the documents to 78.3877 ha instead of 81.1717 ha. The maps, layout plans, kml etc files have also been changed accordingly.
2	The forest area recommended by the CF/DFO is 78.3877 ha, whereas NPV has been assessed for 81.1717 ha and enumeration of the trees/ saplings involved in 81.1717 ha has been uploaded. Revised NPV sheet and enumeration list of trees needs to be uploaded.	The revised NPV calculation sheet, area calculation sheet and enumeration list have been uploaded under additional documents Part-II
