Further the Managing Director, KNNL, Bengaluru has instructed to drop the proposal of construction of diversion weir from the scope of above said work and to obtain forest clearance accordingly vide their letter cited under ref- 3 (Copy enclosed).

Referring to your letter cited under ref-2, for the EDS raised, (clarifications /additional) information sought regarding the following aspects of the project, the compliance report is here with submitted as follows:



Sl No	Observation	Compliance
1	The area required for submergence and laying of pipe line and corresponding KML files and maps should also be included in the proposal.	As per the 200 <sup>th</sup> TSC-KNNL Bengaluru, proceedings of the meeting held on 04-10-2024 and as per the directions of MD KNNL Bengaluru vide their letter dt: 28-10-2024, the Diversion weir proposed has been dropped from the scope of above said work. Hence, now the question of taking in to consideration of submergence area dose not arise as there will be no submergence in the river course. For laying of pipe line, the area required has been taken in to consideration and the corresponding KML files and Maps have been uploaded in PARIVESH PORTAL.
2	As the Protected area forms part of tiger Reserve, the map with respect to the project proposal should clearly indicate the boundaries of core zone and buffer zone of the tiger reserve.	As the Protected area forms part of tiger Reserve, the relevant maps with respect to the project proposal clearly indicating the boundaries of core Zone and buffer Zone of the tiger reserve has been uploaded in the PARIVESH PORTAL.
