Dear Sir,

It is brought to your kind attention that DVC has undertaken the construction work of 220 KV double circuit transmission line, which would originate from our Parulia Substation and would terminate at our Burdwan Substation, in order to cope up with manifold progressive load demand in the lower Damodar Valley region. The said transmission line passes through some forest land at Barchatra Mouza under your block as identified by the BL&LRO, Ausgram-I mentioned under Reference (2) above (copy enclosed). For obtaining NOC from forest department compliance of forest right act (FRA) from district administration is required, if applicable.

Under the above circumstances, towards compliance of forest right act (FRA), kindly arrange to provide the details of Patta of the plots mentioned in attached letter under your block, if distributed to any forest dwelling Schedule Tribes and other traditional forest dwellers.




