### Specific recommendation of the DFO.

The area proposed for renewal of mining lease is small 3.56 Ha ( 2.43 Quarry + 0.66 Ha road + 0.47 Ha safety ). Previously mining lease was approved over an extent of 3.61Ha ( 2.94 mining + 0.67 road). Out of 2.94 Ha of approved lease area for mining, an extent of 1.00 Ha was extracted so far. At present an extent of 1.43 Ha is available for quarrying. Most of the area proposed for renewal covered with small hillock and rocky patches. The density of vegetation is 0.2. Only thorny species are available in the proposed area. Hence recommended the renewal proposal.
