Reply against the Essential Details Sought (EDS) by Nodal Officer (FC Act) for Forest Clearance (FC) application of Loc. DHD on 21.12.2017

Query:1: C-(iii) – On scrutiny of the uploaded scan copy of 1:50,000 scale SOI toposheet map it has been observed that the depicted Plinth area has not been accompanied with the essential DGPS/total Station coordinates points, the co-ordinates readings of the proposed Plinth area. Hence a fresh map maintaining the full 1:50,000 scale toposheet reflecting the Plinth area along with the DGPS/Total Station coordinates points and co-ordinates readings may be uploaded.

- **The full 1:50,000 scale toposheet reflecting the Plinth area along with the DGPS/Total Station coordinates points and co-ordinates readings has been uploaded on the MOEF & CC portal.**

Query:2: I-(ii)- No action has been taken for providing the sought for data as E-communicated vide our observation dated 17/08/2017. So furnished the same.

- **The document for Wildlife Clearance shall be submitted as soon as the Forest Clearance proposal will be accepted, since Forest Clearance proposal number is mandatory for Wildlife Clearance application as per the MOEF &CC online portal.**

Query:3: K-(ii) – No action has been taken despite specific request vide our E-communication dated 17/08/2017 for furnishing the FRA 2006 certificate from the concerned Deputy Commissioner. So furnished the same.

- **The application for obtaining the FRA certificate has been submitted to DFO & DC Tinsukia. The undertaking for the FRA-2006 certification has been submitted at this stage to process the application. FRA certificate will be submitted before the final approval of the proposal by the MOEF&CC.**

Query:4: M-2-(iv)-The uploaded document is a copy of 3-D subsidence analysis report and not the required Approved Mining Plan. So kindly upload the copy of Approved Mining Plan.

- **Approved mining plan has been uploaded on the MOEF &CC portal**

Query:5: M-2-(vii) - After verification of Petroleum Mining Lease area KML files uploaded in the Column no. M-2-(vii) on 11/12/2017 found to be not matching with the approved Petroleum Mining Lease area. The encompasses area of the KML files relating to Dumduma Petroleum Mining Lease area does not tally with the approved area reflected in the Govt. of Assam letter no. PEM.26/2010/27 dated 26th November 2012. The approved area is for 503.73 km² whereas the KML file encompasses an area of 498.46 km². So the KML files may be rectify / clarify and upload and also arrange to send a copy of the same to our Email address addlpccf.nodal@gmail.com.


- **The map of the outer boundary of mining lease area has been uploaded on the MOEF &CC portal.**
