Reply against the Essential Details Sought (EDS) by Nodal Officer (FC Act) for Forest Clearance (FC) application of Loc. DGR on 10.09.2018

Query:1: C-(iii) - The uploaded SOI toposheet 1:50,000 scale map does not show the proposed drilling location DGR. A map of proposed diversion area maintaining full 1:50,000 scale on SOI toposheet reflecting all the diversion activities along with mandatory components, appropriate legends, DGPS/Total Station coordinate points and DGPS/Total Station coordinate readings should be uploaded.

- **The revised toposheet has been uploaded on the MOEF &CC portal.**

Query:2: I. (ii) - Please apply Wildlife Clearance proposal also through online for approval of the Standing Committee of NBWL and thereafter a copy of the "application form" seeking Wildlife Clearance should be uploaded along with reference no and date of issue.

- **The document for Wildlife Clearance shall be submitted as soon as the Forest Clearance proposal will be accepted, since Forest Clearance proposal number is mandatory for Wildlife Clearance application as per the MOEF &CC online portal.**

Query:3: K-(i).(a) - The area 2.826 ha mentioned in the uploaded FRA 2006 clearance certificate does not matched with the area 3.411 ha for proposed drilling location DGR. Please clarify.

- **The application for area amendment in FRA certificate has been submitted to DFO & DC Tinsukia. The undertaking for the FRA-2006 certification has been submitted at this stage to process the application. FRA certificate will be submitted before the final approval of the proposal by the MOEF&CC.**

Query:4: M-1.(i).(a)- The Reference number of Letter of Intent for grant of Mining Lease mentioned in the column no. M-1.(i).(a) does not match with reference no mentioned in the uploaded copy of re-grant of Dumduma PML measuring an area of 503.73 sq.km to Oil India Limited. Please clarify.

- **The Reference number of Letter of Intent for grant of mining lease has been updated with No.PEM.26/2010/27, dated 26.11.2012 on the MOEF &CC portal.**

Query:5: M-2.(iii) – The uploaded copy of document is not a copy of approval of mining plan, but it is a copy undertaking for Letter of Intent stating that, under PNGR 1959 Letter of Intent is not applicable and PML is granted without Letter of Intent. So kindly upload the copy of approval order / letter of mining plan.

- **PML is granted by the State Government with the prior approval of Central Government as per PNGR 1959. Approval of mining plan is not prerequisite condition in PNGR as applicable in MMDR 1957. The undertaking along with the copy of the PML issued by the State Government is attached.**

Query:6: M-2. (iv) - The uploaded copy of document is not the approved mining plan. Rather uploaded document is a copy of re-grant of Dumduma PML measuring an area of 503.73 sq.km to Oil India Limited by Govt. of Assam. So kindly furnished a copy of approved mining plan.

- **Approved mining plan has been uploaded on the MOEF &CC portal**

Query:7: M-2.(vii) – After scrutiny of the KML file of outer boundary of mining lease area, the calculated area comes to 301.20 sq.km area while 503.73 sq.km area is mentioned in the copy of re-grant of Dumduma PML measuring an area of 503.73 sq.km to Oil India Limited by Govt. of Assam. So rectify the KML file and upload accordingly.


- **The map of the outer boundary of mining lease area has been uploaded on the MOEF &CC portal.**

Query:8: M-3.(i)- The designation of authority responsible for grant of the original prospecting license mentioned in the column no M-3.(i) does not match with designated authority mentioned in the uploaded document. Please clarify.

- **The designation of authority responsible for grant of the original prospecting license has been updated with MoPNG & State Govt, Assam on the MOEF &CC portal.**
