1	In reply to point no.-1,it is mentioned that the revised KML file as well as other maps showing existing road to which the proposed road will connect are uploaded in para-C(ii) of online part-I but,the existing road is not shown/named in the documents uploaded.	Uploaded in para C(ii) of part -I
2	In reply to point no.-2,it is mentioned that the revised digital map showing alternatives explored is uploaded in para-D(a) of online part-I but,it is seen that the map uploaded is again on google earth image and not GIS software generated geo-referenced digital map.	Uploaded in para D(a) of part-I
3	In reply to point no-3&4,it is mentioned that the FRA certificate along with all other documents is uploaded in para-K.But,it is seen that the name of 3 villages i.e.Nalgaon,Lakheri&Vasisem are mentioned in the FRA certificate but,the name of only one village i.e Lakheri is mentioned in the proceedings of Gram Sabha.Moreover,name of 4 village i.e Maikholi,Khinsar,Nalgaon&Lakheri are mentioned in para-B 2.3(Village wise breakup) in part-I	Lakheri is the only Revenue village which is comprises of two Tok(i.e. Nalgaon &Vasisem) That's why in proceedings of Gram sabha only Lakheri village proceeding are provided village wise breakup corrected in para B(2.3) of part-I
4	In reply to point no.-5,it is mentioned that the revised KML file for the areas selected for CA has been uploaded in para-	Corrected in para L(iv) of part-I

	L(iv).KML file for 3 patches i.e. 1 patch measuring 2.586 ha in Dandyal Civil and 2 patches measuring 1.718 ha (0.91 ha & 0.778 ha) in Shilanga Civil are shown in the KML file uploaded but the no. of patches is mentioned as 2 in para-L(iv) of online part-I	
5	In reply to point no.-6, it is mentioned that the revised documents mentioning that the civil land will be spared for CA are uploaded in para-L(iv) of online part-I but, no such documents are found uploaded.	Uploaded in para L(iv) of part-I
6	In reply to point No.-8, it is mentioned that the revised geo-referenced digital map showing geo-coordinates for the CA area is uploaded in para-L(iv) of online Part-I but, the scanned copy of the map uploaded is yet again in google earth image only.	Uploaded in para L(v) of part-I
