No. D(5)-61/IND/2019: In supersession of the orders of even number dated 7-12-2018 issued earlier in this regard and in exercise of the power conferred by Rule 4(2) and Rule 5(1) of the Manipur Minor Mineral Concession Rules, 2012 and in consideration of the application No. nil dated 26/09/2019 submitted by Shri L. Noren Singh, Proprietor, M/s. Noren Enterprises, Brahamapur Nahabam, Imphal East District for the grant of quarrying lease of Murum and slaty soil/shaly soil (earth), the Director of Trade, Commerce & Industries, Govt. of Manipur is pleased to convey its approval to the grant of **Quarrying Lease** to Shri L. Noren Singh, Proprietor, M/s. Noren Enterprises, for quarrying of Murum and soil/shaly soil (earth) over an area of 5.5 Hectares including approach road from NH-37 at Lhongchin village, Kangpokpi District, Manipur for a period of 10(ten) years commencing on the date of execution of Quarrying Lease Deed within the area bounded by the geographical limits as below:

2. The grant of this lease shall be subject to the following terms and condition:


(i) Payment of fee, security deposit and financial assurance will be made as per Rule 34, Rule 35 and Rule 40 of the Manipur Minor Mineral Concession Rules, 2012.

(ii) Submission of Mining Plan along with requisite fee under Rule 49C of the Manipur Minor Mineral Concession (Amendment) Rules, 2018 and also Rule 39(4) and 49 A of the Manipur Minor Mineral Concession Rules, 2012.

(iii) The lessee shall strictly adhere to the conditions laid down in Rule 39 of the Manipur Minor Mineral Concession Rules, 2012.

(iv) The lessee shall comply with the related provisions of Environment (Protection) Act, 1986 and Forest (Conservation) Act, 1980 and rules and Notifications issued from time to time.

3. The Quarrying Lease Deed shall be executed in prescribed Form-H after fulfilling the conditions required in Sl.No. 2(i), & 2(iii) above and after obtaining of Environmental Clearance and Forest Clearance. **The quarrying operation shall be permitted only after execution of Quarrying Lease Deed.**
