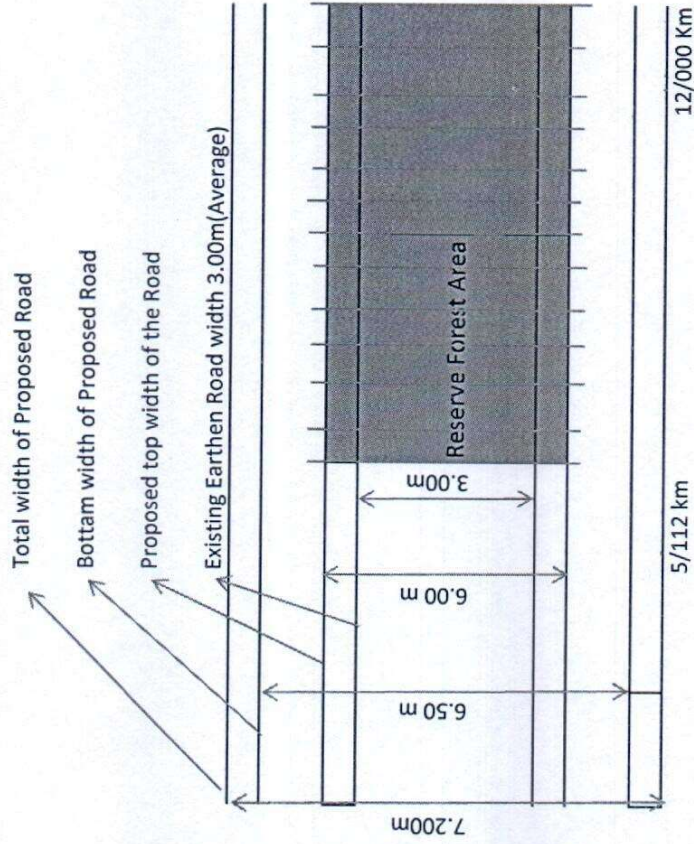

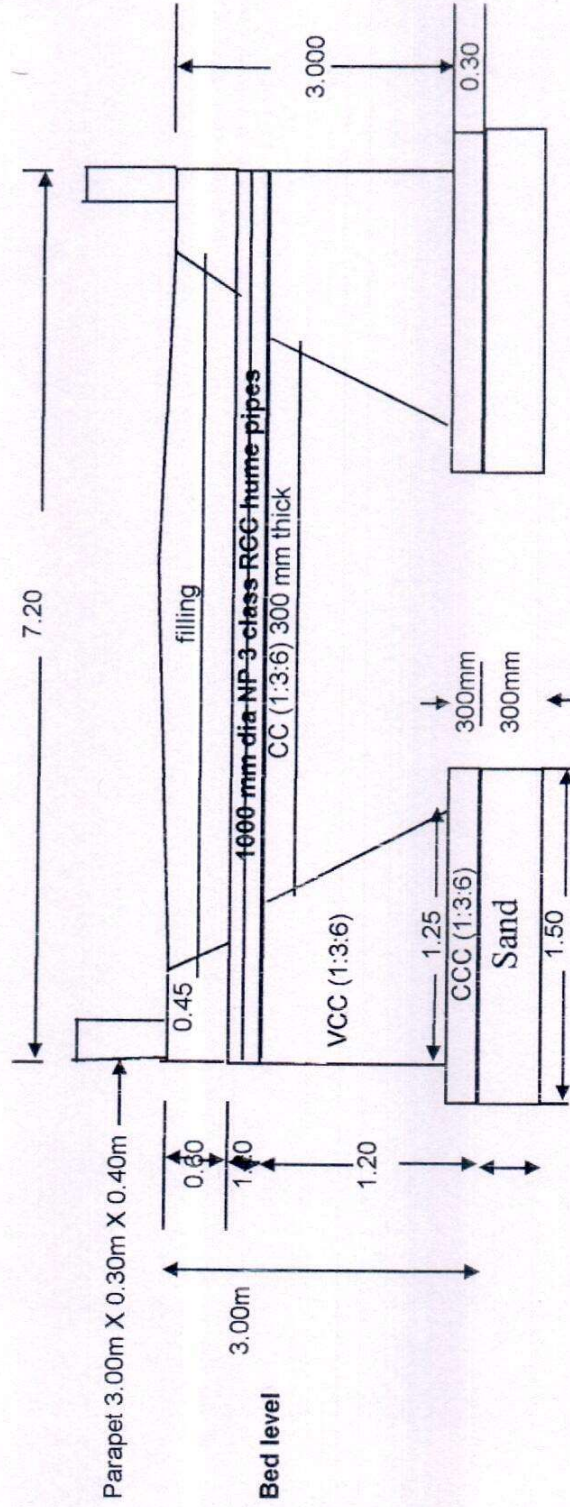

Construction of 1000 mm dia RCC pipe culvert



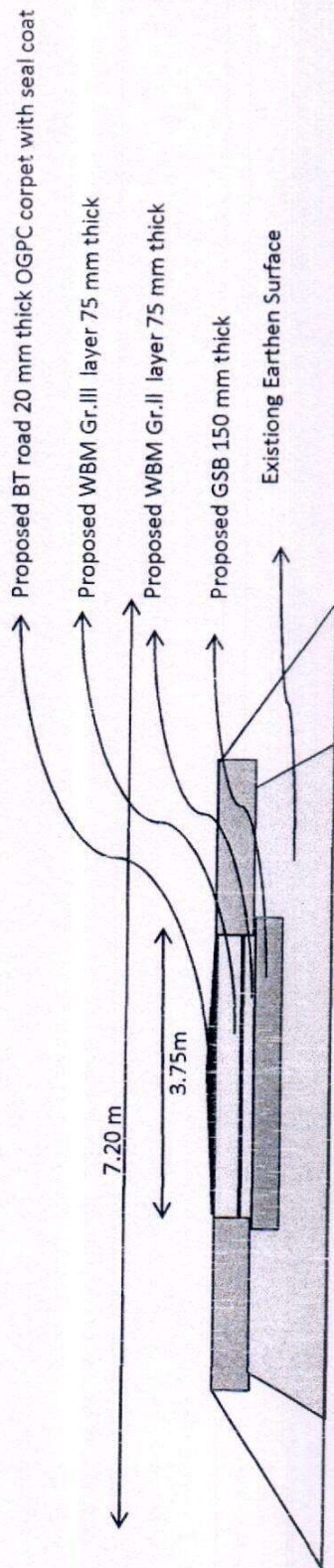
