13	Recommendations of the committee (should include length in kilometers, extent of forest land additionally required for completing the work, expenditure to be incurred on engineering/ vegetative works necessary for stabilizing the soil/ boulders and upper and lower sides of the road etc.)	(i) The committee observed that the total length of proposed road is 4 km out of which 2.035 km (1.1559 Hect.) is forest area. An amount of Rs. 10,50,000/- is likely to incurred for stabilizing the soil on upper and lower side of the road. The same is recommended so that the road is made all weather by stabilizing the road sides. (ii) The user agency under takes to pay the penal amount if any to be levied by Regional Officer/MOEF Deharadun.
