1.	Again the incorrect Forest Rights Act (FRA), 2006 certificate is enclosed on which has letter number and seal of DM is missing and proposed area is varying for Diversion of Forest Land. Hence, submit either the corrected FRA certificate or Undertaking against FRA Certificate and upload at designated place in both PART-I and PART-2 on online portal.	We have requested to DM, Jhansi (ref. EE letter no. 726/A-6 dt. 14.11.2022) to issue revised FRA Certificate by correcting Forest Area as proposed for Diversion. As suggested by the Nodal Office, the copy of old FRA certificate has been deleted from Online Part-I in Parivesh as well from the hardcopy of proposal. In lieu of it, once again we are submitting herewith an undertaking for FRA Certificate as Annexure-1 for your signature so to submit at designated place in Online Part-I and Part-II section of parivesh portal and hard copy of proposal.
2.	Online Part-2 under serial no. 13 (iv) the CA estimates has not been uploaded.	Jhansi Forest Division is requested to upload the estimates of Compensatory Afforestation Scheme at designated place in Online Part-II section of Parivesh portal.
3.	In proposed FC the heading on SoI Toposheet is incorrect that is required to be corrected and upload the corrected SoI Toposheet at designated place in both PART-I and PART-2 on online portal.	Correction has been done in hardcopy of file and same has uploaded in Online Part-I. DFO, Jhansi office is required to upload the same in Online Part-II.
4.	PDF File of revised corrected FC Proposal shall be submitted in Pen Drive incorporating the above mentioned EDS.	All above issues are complied at User Agency's end and the PDF copy of revised FC Proposal is enclosed in Pen Drive.

Therefore, you are requested for this high prioritized road development project of GoUP to provide the essential details in online PART-2 on Parivesh Portal and recommend the forest diversion so that Stage-I (In-principle) Forest Clearance can be obtained from Government of India under Forest (Conservation) Act, 1980.
