		As per the Reserve Forest block notification of Singanapalli-A issued by the Forest Department, Right of Way is admitted to a width of 20 Mtrs for the said road and for Udayagiri Yarragonda RF ,Gazette details are not available and as per road charts of R&B, this road is formed before 1980 and the road width is 30.0.The width of existing road in Singanapalli-A RF is 16.00m and in Udayagiri Yerragonda RF is 17.00m (including B.T, gravel shoulders, side slopes) .For widening of the road to two lane with paved shoulders, a width of 20 m is required. Hence permission for diversion of forest land is being initiated for the additional width required for widening of the road. As per the area statement enclosed, <b>0.933</b> Ha of forest land is required for diversion.
