This proposal shares boundary with already approved projects | mining. Hence, this project should not be viewed as stand alone and a holistic assessment is required.

Answer

Proposed Bangwar Coal Mining Underground Project (area 36.734 Ha) is adjoining to the ongoing Bangwar underground coal mining project spread over 315 Ha of the area beneath the forest land. The proposed project is, in fact an expansion of the ongoing Bangwar underground coal mining project for the last 32 years. Any damage noticed on the surface of the ongoing project is the only authentic evidence for subsidence analysis, whereas in this project incidentally there is no evidence of subsidence more than 1.5 Mtrs. This project is under operation since 1989(i.e, since past 32 years). Uptill now mining activity has been done at approximately 70% of 315 Ha area.

Further, the technical team of the mine is very systematically recording the surface features and simultaneously treating the minutest cracks developing because of subsidence. Latest observations were recorded on the site on 11.11.2021 along with expert Forestry Advisor and the evidences were verified. On the basis of above facts, it is humbly requested that the proposal for expansion of the project over 36.734 Ha may kindly be approved.

A nallah named Kachhian nallah, passing through the proposed area has been proposed to be diverted for mining under it. But proposed diverted route is not given. No report of concerned department of the state government is available in the matter.

Earlier the diversion of Kachhian Nallah flowing through the project area was proposed to be diverted, but now it is proposed to drop the diversion of the nallah and accordingly we have modified the subsurface mining plan in such a way that width of 60 Mtrs below the Nallah on either side of the stream is left untouched. It is therefore requested to agree with the proposed modification & accord approval accordingly.

proposal Though present underground mining, there will be significant effect on surface after completion of the mining. After mining is completed, there will be formation of depression (due to subsidence) in 20mX20m block. Changes like diversion of water course and formation of new water depressions can have significant effect on flora and fauna of the area

As explained in para number 1 above, there is hardly any evidence of effect of underground mining on the flora and fauna on the forest land. As per the guidelines of DGMS the treatment of cracks and subsidence marks is simultaneously being done by the technical team of the Project. In addition, all guidelines and provisions mentioned in permission of MOEF are being fully complied. Despite the undergound mining operations in the adjoining area for the past 32 years, no significant damage to flora & fauna is recorded. The photographs obtained on 11.11.2021 (along with the geographical index) is submitted for your kind perusal. As already stated above in Para No.-2, in view of the proposed dropping of the diversion of Kachhlan nallah, no likelihood of any adverse Impact on the flora and fauna on the surface is foreseen.

You are therefore kindly requested to accord sanction for the expansion of the underground mining operation beneath the 36.734 Ha forest land of Bangwar UG Project.
